

I'll let the attorney know to reach out directly to you with comments. I have not heard back from him yet on whether he can review, will follow up tomorrow morning

I'll also let him know this is time critical with a property transaction on the line.

The comfort letter would essentially go like this - Dunbar Carpenter, Veritas Properties, LLC is working cooperatively with DEQ and has developed a cleanup plan that DEQ has approved. We have completed public comment on the proposed action. We feel that once complete the remedial action (RA) will result in a property safe for unrestricted use, including residential development. The placement of soil containing low levels of contamination in an on-site repository (currently planned for a soilar array), will also be protective. We anticipate issuing a no further action (NFA) determination letter following the completion of the site work in accordance with the remedial action jain.

I'd also add some other language like Dunbar is intent to ensure that the cleanup is completed in accordance with the plan and will receive a gold star once complete Okay- totally kidding about the gold star part... unless you want that in there. It's getting late in the day and I'm feeling a bit punchy.

The engineer review will not delay the NFA. If she has questions about the vegetative cap, then we'll address them. The things delaying the NFA right now are the draft EES and the SRMP. I need the SRMP to attach to the EES before it is signed, notarized, and recorded with the county Once we have the recorded EES I can complete the draft NFA, route it to Don (lead worker) and then Brad Shultz (manager) for signature approval. We usually need to submit a final invoice request to the financial department before we can give you the final NFA. This could take a few months with our current accounting system. We could also ask for a final invoice estimate and have you send a check, or ACH deposit, to get the balance paid before you receive the final invoice. I will ask Brad when he gets back on Tuesday next week if we can send you the NFA before the final payment is received... unless you still have a balance from the VCP deport I can check and see where we are at with the invoicing later this week. I have amended the EES and titled it DC DEQ Draft 2. My proposed changes are in Italics, and the strike-throughs are self explanatory. I will require any leaseholder, including Hawthorne Renewables, to make annual inspection reports to me regarding compliance with the EES, which I will keep on file. Under current plans, Hawthorne would be a 30 year lessee. I will ask them to take photos to submit with the annual reports, but I have not included that language in the EES.

I removed my name as a Grantor, because I have no legal ownership in the land. I am an interest holder in the LLC, and am authorized to sign legal documents on its behalf.

As noted in our recent telephone conference, the soil on the repository is likely to be less contaminated than the untouched 12 acre former orchard property on the northern portion of Tax Lot 900. I plan on posting no trespassing signs on both areas.

Please review with Don and get back to me and Jonathan when you can. I will contact a surveyor to get an easement property description.

It would be very helpful to see a SRMP if you have one on file.
