Executive Summary:

The city currently owns and operates a Caterpillar 930 K Front End Loader. It is currently scheduled for replacement in 2024.

The City employs this loader in the operation of the Wastewater Treatment facility's composting operation. It is used in the loading and unloading of compost cure bays, loading of sawdust and recycled compost to be processed in the mixing system, excavation of compacted compost in cure tunnels, loading of customer vehicles and as a high-capacity forklift in various maintenance projects throughout the wastewater treatment plant. The loader is operated every working day of the year and is critical to the operation of the facility. Any machine down time results in the inability to remove solids from the wastewater plant, affecting the performance of the treatment process and exposing the city to potential permit violations. The current loader has experienced multiple electrical and mechanical issues resulting in downtime and added rental expenses. It will also need a new set of tires within this budget year. These items led us to reevaluate its currently scheduled replacement date.

When reviewing loader options John Deere emerged as a clear favorite. They offered a comparable machine for nearly \$50,000 less while offering an extra \$10,000 in trade on the current loader. Customer service was more responsive throughout the process and parts should be equally accessible with a large dealership in Portland, Or. John Deere offers an initial 1-year warranty period to address any issues.

Purchase of the John Deere 544 Loader would utilize funding approved in the Fiscal Year 2023-2024 budget, as per NMC 3.25.080 (F) Cooperative Procurement Contracts, utilizing Sourcewell contract #032119-JDC, which meets the requirements of ORS 279A.205 and ORS 279A.220.

The City of Newberg is a member of the Sourcewell Cooperative Purchasing Agreement, ID number 64,098,

Fiscal Impact:

The John Deere 544 Loader will be fully funded from the Capital Outlay account 06-5131-610000. Initial cost of \$211,472.00 with a \$90,000 trade in credit for a final cost of \$121, 472.00. By purchasing a new loader this year, the city can avoid the new tire cost of \$16,700 as quoted by Caterpillar that would be incurred this summer, along with any other maintenance, repair or rental costs associated with the older machine and its previously discussed issues, and take advantage of current market conditions that have increased the trade in value from \$49,500 to \$90,000, making the final purchase price on this model slightly less than the machine purchased in 2014.

Recitals:

- 1. The City of Newberg PW Operations Division utilizes its front wheel loader for the operations of its composting facility.
- 2. The 2014 front wheel loader is nearing its replacement date. It has also experienced several mechanical issues and is due for tire replacements which come with an anticipated cost of \$16,700. Replacement of the front wheel loader will allow staff to realize the technological and efficiency improvements, as well as avoid the upcoming expensive maintenance activities.
- 3. Purchase of the John Deere 544 Loader would utilize funding approved in the Fiscal Year 2023-2024 budget, as per NMC 3.25.080 (F) Cooperative Procurement Contracts, utilizing Sourcewell contract #032119-JDC, which meets the requirements of ORS 279A.205 and ORS 279A.220. The City of Newberg is a member of the Sourcewell Cooperative Purchasing Agreement, ID number 64,098.
- 4. The City selects Pape Machinery to provide a new 2023 John Deere 544 Hi-Lift Front End Wheel Loader at a final cost of \$121,472.00.

The City of Newberg Resolves as Follows:

- 1. The City Council, acting as the Contract Review Board, authorizes the city manager to enter into all contracts and agreements for the purchase of a replacement 2023 John Deere 544 Hi-Lift Front End Wheel Loader.
- 2. The City will purchase the 2023 John Deere Hi-Lift Front End Wheel Loader by using funds from the wastewater capital outlay account 06-5131-610000
