#### 1. Community Involvement Program Overview

A comprehensive community involvement program is essential for the Lincoln School Cleanup Project. The purpose of this Community Involvement Plan (CIP) is to explain communication strategies that will address the needs and concerns of the citizens of Harney County and the City of Burns, particularly the residents or community groups potentially affected by activities conducted during cleanup of the former Lincoln School property. This CIP outlines how community members will be engaged throughout the cleanup process.

Harney County received a FY2023 EPA Brownfields Cleanup Grant (Cooperative Agreement No. 4B-02J52001) that will be used to properly and safely remove hazardous building materials and a heating oil aboveground storage tank at the former Lincoln School. Due to potential health hazards related to removal of these materials, open and transparent communication is vital to ensuring the community is informed throughout the cleanup process.

The County will hold at least two public outreach meetings at key project milestones and use media/newsletter/bulletins and document repositories to inform the community of project activities. Community residents and organizations are essential resources for the success of the CIP because they hold positions of responsibility within the community. The success of the environmental cleanup project hinges on informed citizen involvement in each step of the process.

This document was prepared under the Intergovernmental Agreement (IGA) between Harney County and Oregon Department of Environmental Quality (DEQ).

## 2. Project Background

The Lincoln School site (1.99-acre parcel) is located at 550 North Court Avenue, Burns, Oregon. Originally developed in 1928, the 28,374-square foot (SF) three-story building was the primary school for Burns until its acquisition by Harney County School District in 1964. The building was renovated and seventh and eighth graders moved into the building in 1965, and it was renamed Lincoln Junior High¹. The school building has several classrooms, office spaces, a gymnasium, locker rooms, restrooms, and auditorium. A separate 1,700 SF shop building is located to the west of the school building and is still used by the school district for storage. Additionally, on-site paved walkways and a concrete sports court are present on the west portion of the property. The school building had been vacant and unused since approximately 2000. Harney County purchased the property in September 2022.

Environmental assessments of the site identified the presence of asbestos-containing materials (ACMs) and lead-based paint (LBP) throughout the on-site buildings. The basement of the building also contains a 10,000-gallon heating oil aboveground storage tank (AST) within a secondary containment structure. Specifically, regulated quantities of asbestos were identified in floor tiles and underlying mastic, drywall joint compound, roofing penetrations, pipe insulation, boiler insulation, and exterior caulking. The pipe and boiler insulation were observed to be in poor to fair condition, with visual deterioration. LBP was identified on interior concrete masonry unit (CMU) walls in light gray paint and gray paint. The heating oil tank appeared to be in good condition, but must be

removed in accordance with DEQ regulations. The locations and quantities of these materials are detailed in the following table.

Given the building's 96-year history the community supports keeping the building and addressing the potential health concerns associated with the ACMs and LBP located throughout the interior and exterior building features. The site, located in Census Tract 9601.02, is surrounded by sensitive populations, with single-family residences within 50 yards to the east, north, and south, and St. Andrews Episcopal Church with a daycare to the adjacent south. Before redevelopment can begin, these hazardous materials must be removed to address the potential for negative impacts on these populations.

Harney County, located in southeast Oregon's high desert, is comprised of 10,228 square miles with a population of 7,575. The County is geographically Oregon's largest and is the 10th largest in the continental United States. The City of Burns is one of the two primary population centers in the county with 2,714 residents. The redevelopment will result in the creation of four to five additional permanent living-wage jobs in Burns.

#### 3.2 Key Project Staff and Roles

<u>Harney County</u>: The project will be led by Harney County, the grant recipient. Harney County, with support from DEQ, will complete required cooperative agreement reporting including quarterly cooperative agreements reporting; MBE/WBE reporting; Assessment, Cleanup and Redevelopment Exchange System (ACRES) entry; final financial status reports; and final performance report. Harney County will also perform project communication actions and community involvement. Key Harney County staff are listed below.

- Lt. Roxane Worley, Harney County Jail Commander, will serve as the primary project contact.
- The Honorable Bill Hart, Harney County Judge, will serve as the project sponsor.
- Bobbi Jo Heany, Harney County Treasurer, will serve as the financial coordinator.

<u>Oregon Department of Environmental Quality</u>: DEQ will provide technical oversight of all activities performed under this cooperative agreement, including the review and approval of the cleanup sampling and analysis plan, and the cleanup report, to ensure proposed actions are consistent with federal and state regulations. DEQ and its contractor will serve as Qualified Environmental Professionals for Harney County. Key DEQ staff are listed below.

- Kara Master, Brownfields Coordinator/Project Manager, will serve as the primary project contact.
- Katie Daugherty, R.G., Brownfields Coordinator/Project Manager/Hydrogeologist, will serve as the project peer, and lead worker.

In addition, to facilitate the cost effective and efficient procurement and management of consultants and other necessary subcontractors, Harney County and DEQ entered into an IGA as encouraged by 40 CFR Part 31 Section 36(b)(5) to utilize DEQ existing procurement process. DEQ has three environmental consultants on standing contract that were procured in accordance with federal and state requirements. Maul, Foster & Alongi, Inc. (MFA) was assigned as the on-call environmental consultant for this project to provide technical support. Key MFA staff are listed below.

 Chris Clough, Project Environmental Scientist/Accredited AHERA Building Inspector/AHERA Project Designer, will serve as task order manager.  Michael Pickering, R.G., Principal Geologist, will serve as the task order program manager and senior reviewer.

<u>U.S. Environmental Protection Agency</u>: Margaret Olson is the EPA Brownfield Project Officer for Harney County's grant and will be responsible for ensuring key elements of the grant administration and reporting requirements are met.

#### 4. Goals and Objectives of Community Involvement

Redeveloping brownfields is a long-term, multi-step process. Keeping the public informed and engaged in the former Lincoln School Cleanup Project can help achieve project goals and reduce community concerns due to a lack of project knowledge.

Priorities for public involvement include:

- Education about brownfields and asbestos and lead-based paint removal and/or encapsulation;
- Ensuring project objectives and cleanup activities are explained to the local communities closest to the project site; and
- Consulting project partners and community leaders for assistance in achieving project and public information objectives.

#### 5. Planned Community Involvement Activities

Public involvement for the cleanup project will begin in Spring 2024 with a public meeting. The meeting will include a presentation to broadly review cleanup activities followed by a question-and-answer period. A community meeting discussing the cleanup alternatives and grant application was previously conducted on behalf of Harney County. The types of public involvement activities planned for the project are summarized in the subsections that follow.

#### **5.1 Brownfield Cleanup Webpage**

A project webpage will be designed and updated regularly with new project information and links to additional information about brownfields. The webpage will be housed on Harney County's website (https://harneycountyor.gov/lincoln-cleanup-project/).

The webpage will include the following elements:

- Information about the project, including the EPA and DEQ logos
- General information about brownfields
- Timeline of project activities
- Meetings information, status updates, and news
- Project fact sheet(s)
- Contact information to send comments, questions, or inquiries to the Cleanup Project Manager
- A link to the DEQ project documentation as discussed further in Section 5.2.

#### **5.2 Information Repository**

Information on the EPA Brownfield Cleanup Grant will be maintained/stored at the Harney County Court office of Judge Hart. Hard copy documentation related to the project will be kept accessible to the public.
