WHEREAS, the Curry County Comprehensive Plan ("CCCP") establishes a Citizens Committee for Involvement ("CCI") in order to adhere to the requirements of the Land Conservation and Development ("LCDC") Goal 1 – Citizen Involvement; and

WHEREAS, the Curry County CCI was active during the development of the CCCP, 1976-1984, and again during the Brookings Urban Growth Boundary amendment process, 1999-2000; and

WHEREAS, multiple counties throughout Oregon have combined the roles of the CCI and the Planning Commission for the purpose of adhering to the requirements of LCDC Goal 1.

## NOW, THEREFORE, THE BOARD OF CURRY COUNTY COMMISSIONERS HEREBY ORDAINS AS FOLLOWS:

#### SECTION I TITLE

This Ordinance shall be known as Ordinance No. 23-02 and may be cited as "Ordinance Allowing the Planning Commission to Serve as the Citizens Committee for Involvement."

### SECTION II AUTHORITY

This Ordinance is enacted pursuant to the authority vested in this governing body to make decisions regarding the constitution of the Curry County CCI.

# SECTION III PLANNING COMMISSION TO ACT AS CITIZENS COMMITTEE FOR INVOLVEMENT

This Ordinance allows the Curry County Planning Commission to act as the Curry County Citizens Committee for Involvement for the purpose of carrying out the Citizen Participation program (Goal 1) for Curry County during a comprehensive plan amendment process in accordance with the CCCP Goals and Policies.

### SECTION IV ADOPTION

The provisions of this Ordinance are hereby adopted and shall be effective upon the date of this Order and shall remain in force and effect until otherwise ordained by the Board of Curry County Commissioners.

### SECTION V SEVERANCE CLAUSE

If any section, subsection, paragraph, sentence, clause or phrase of this Ordinance, or any part thereof, is for any reason held to be unconstitutional or otherwise invalid, such decision shall not affect the validity of the remaining portions of this Ordinance or any part thereof. The legislative body hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof, irrespective of the fact that any provision be declared unconstitutional or otherwise invalid.

### SECTION VI EMERGENCY CLAUSE

The Board of Commissioners for the County of Curry deems the adoption of this Ordinance to be necessary for the immediate preservation and protection of the public peace, health, safety, and general welfare for Curry County, and to facilitate the timely completion of important County business. Therefore, it is declared that an emergency exists, and this Ordinance shall be in full force and effect upon its adoption.

### SECTION VII EFFECTIVE DATE

This Ordinance shall become effective upon the date of this Ordinance.
