RESOLUTION NO. R2023-15

WHEREAS, on May 22, 2023, the governing body of the Curry County 4-H and Extension Service District ("District") met to hear public comment on the 2023-24 budget for the Curry County 4-H and Extension Service District, as approved by its Budget Committee, which has been published according to law; and

WHEREAS, that budget requires an ad valorem property tax rate on all property within the District in the amount of \$0.1021 per thousand dollars (\$1,000.00) of assessed value.

NOW, THEREFORE, BE IT RESOLVED that the governing body of the Curry County 4-H and Extension Service District hereby adopts the budget for fiscal year 2023-24 in the sum of \$1,461,557.00 now on file at the Curry County Extension Service Office; and

BE IT FURTHER RESOLVED that the following appropriations are made for the Curry County 4-H and Extension Service District for the fiscal year beginning July 1, 2023, and ending June 30, 2024:

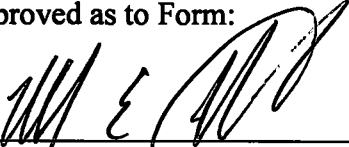
