BUSINESS MEETING MINUTES

February 15, 2023

1. CALL TO ORDER & PLEDGE OF ALLEGIANCE

The meeting was called to order by Chair Herzog at 9:01a.m. Present were Chair John Herzog and Vice Chair Brad Alcorn.

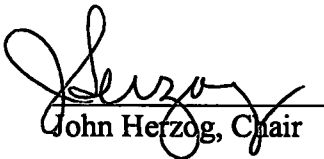

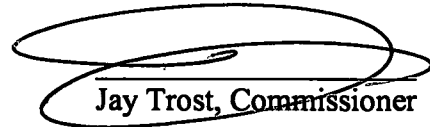
