WHEREAS, the County and PSU wish to extend the term of the IGA until June 30, 2024; and

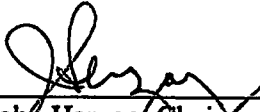
WHEREAS, because the term of the extension crosses into a new fiscal year, the financial obligation resulting from the Agreement will increase; and

WHEREAS, an Amendment to Task Order No. 2 is required to account for the additional cost associated with the extension.

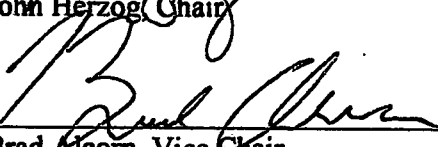

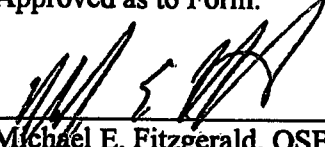

Whereas, PSU and AGENCY wish to amend the Agreement, therefore, the Parties agree as follows:

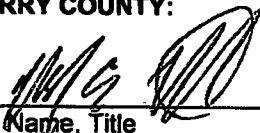
1. Article II, Agreement Period: Extend the term of the agreement to June 30, 2024;

1. Increase the cost for the project to \$26,230, based on the following estimates.

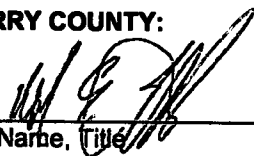

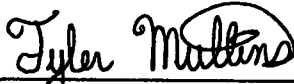
