

The following are the terms of the software agreement between the City of Newberg and Springbrook Software. This agreement covers development, installation, and support of computer software packages developed by Springbrook Software for the City of Newberg's use.

LICENSE:

Software is sold under a license basis only. This means that for the prices quoted for software development, the City is entitled to a paid up perpetual license.

A. This means that Springbrook Software grants the City of Newberg a personal and non-transferable and non-exclusive right and license to use the software packages set forth in paragraph one of this agreement.

B. You and your employees and agents are required to protect the confidentiality of the Program. You may not distribute or otherwise make the Program or documentation available to any third party, by time-sharing or otherwise, without the prior written consent of Springbrook Software.

C. You may transfer the software to another machine or machines owned by the City of Newberg, if you replace the hardware on which the software was originally installed. You also agree to prevent your employees from transferring these software packages.

D. You may not modify or alter the Program. You may not copy or reproduce the Program or documentation for any purpose, except you may copy the Program into machine readable or prepared form for backup purposes in support of your use of the Program on the City Computers. Any portion of this Program merged into or used in conjunction with another program will continue to be the property of Springbrook Software and will be subject to the terms and conditions of this Agreement.

E. You may not transfer or assign the Program or this license to any other person without the prior written consent of Springbrook Software.

F. You acknowledge that you are receiving only a LIMITED LICENSE TO USE the Program and related documentation and that Springbrook Software retains all rights to the Program and documentation. You acknowledge that Springbrook Software has a valuable proprietary interest in the Program and documentation.

G. IF YOU TRANSFER POSSESSION OF ANY COPY OR MERGED PORTION OF THE PROGRAM TO ANOTHER PARTY, YOUR LICENSE IS AUTOMATICALLY TERMINATED.

TERM:

H. The license is effective until terminated. You may terminate it at any time by returning to Springbrook Software, at your expense, the Program and related documentation, together with all copies and merged

portions in any form. The license will also terminate immediately upon conditions set forth elsewhere in the Agreement or if you fail to comply with any term or condition contained herein. Upon such termination, you agree to return to Springbrook Software, at your expense, the Program and related documentation, together with all copies and merged portions of the Program or documentation in any form.

SUPPORT:

Springbrook Software will provide support for the software for five years after it has been installed. Support is defined as follows:

1. Telephone support is included in the package for one year.
2. Additional programming for existing systems will be done for \$20.00 per hour (for one year after installation).
3. After the first year Springbrook Software will maintain the software on an hourly basis, although the rate could increase at not over 10% per year.
4. A maintenance agreement is available after the first year for 15% of the purchase price.

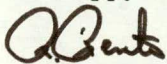
All software has a one year warranty. If it fails to operate as documented in the user's manual, it will be repaired or replaced.
