DEED RESTRICTION AND AGREEMENT

This agreement is made between the City of Newberg, ("City") and Portland General Electric Company ("Owner"), owner of property in Yamhill County, Oregon, more fully described in Exhibit "A" attached hereto and incorporated herein, does hereby agree, consent, and declare as follows:

WHEREAS, An existing fence encroaches into the public right-of-way; and

WHEREAS, It is the City's intention to allow said encroachment within the dedicated Hayes and Hancock Streets rights-of-way until such time that Hayes and Hancock Streets are improved or the parcel redevelops.

IT IS HEREBY AGREED AND UNDERSTOOD THAT:

- Section 1. The City will allow the existing fence and landscaping upon the dedicated right-of-way for Hayes and Hancock Streets provided that the current use of the structure continues and until Hayes and Hancock Streets are improved.
- Section 2. The City will permit routine maintenance and repair of existing facilities by "Owner" within the Hayes and Hancock Street rights-of-way.
- Section 3. "Owners" agree to remove the fence and landscaping in the existing right-of-way at the City's request for street improvement purposes.
- Section 4. Redevelopment of the subject parcel shall void the agreement. Further, the encroaching structure shall be removed by the "Owners" at owner's expense upon redevelopment.
- Section 5. This Agreement, Consent and Declaration shall constitute a covenant and restriction running with the land and shall be binding upon the undersigned, who are the legal "Owners" of the property, and shall bind their heirs, assigns and legal representatives.

THIS INSTRUMENT WILL NOT ALLOW USE OF THE PROPERTY DESCRIBED IN THIS INSTRUMENT IN VIOLATION OF APPLICABLE LAND USE LAWS AND REGULATIONS. BEFORE SIGNING OR ACCEPTING THIS INSTRUMENT, THE PERSON ACQUIRING FEE TITLE TO THE PROPERTY SHOULD CHECK WITH THE APPROPRIATE CITY OR COUNTY PLANNING DEPARTMENT TO VERIFY APPROVED USES.
