### INTERGOVERNMENTAL AGREEMENT

### RECITALS:

WHEREAS, the City of Newberg and the CITY have constructed and operate separate 800 MHz trunked public safety radio systems and have appointed system manager(s), (Exhibit "C") to manage said system; and

WHEREAS, The City of Newberg and the CITY are desirous of allowing their respective 800 MHz radio systems public safety users to communicate on each other's system; and

WHEREAS, the City of Newberg and the CITY will follow all system technical standards outlined under (Exhibit "B"); and

NOW, THEREFORE, In consideration of the terms and conditions set forth below, it is agreed as follows:

### 1. USE

The CITY hereby agrees to permit The City of Newberg and its users, and the City of Newberg hereby agrees to permit CITY and its users, to utilize their respective 800 MHz radio systems for mutual aid radio communications. The talk groups that are authorized to be programmed on each other's system are as outlined on (Exhibit "A"), attached hereto and made a part hereof. Changes to this allowed talk group list shall be in writing approved by both system managers.

### 2. CONSIDERATION

The consideration for the CITY'S allowed use of their radio system and the City of Newberg's consideration for the CITY'S allowed use of their system shall be the mutual use of each entity's system, for mutual aid, and at no cost to either entity or its users for the term of this Agreement.

portland desires to limit the number of agencies who have access to its system key. The City of Newberg will have WCCCA program both their own and the city's talk groups into their radios. In return, the City will allow the City of Newberg access to the same talk groups the City has allowed access to for Washington County agencies.

### 3. INDEMNITY

The CITY shall hold harmless, defend, and indemnify the City of Newberg and its officers, agents and employees against all claims, demands, actions and suits (including all attorney's fees and costs) brought against any of them arising from the CITY's use of the City of Newberg's system. This shall include, but not be limited to, radio programming errors, and the cost by the City of Newberg to rectify same.

The City of Newberg shall hold harmless, defend, and indemnify the CITY and the CITY'S officers, agents and employees against all claims, demands, actions and suits (including all attorney's fees and costs) brought against any of them arising from the City of Newberg's use of the CITY'S system. This shall include, but not be limited to, radio programming errors, and the cost by the CITY to rectify same.

#### 4. TERM

This Agreement shall remain in full force and effect until January 1, 1999, at which time the parties may mutually agree to five year extensions of the Agreement.

### 5. FITNESS FOR PARTICULAR USE

The CITY and the City of Newberg expressly agree that neither party warrants the suitability or fitness of these systems for the intended use.

### 7. GOVERNING LAW

This Agreement shall be governed by the laws of the State of Oregon and any action or suit shall be commenced in Multnomah County Circuit Court unless otherwise mutually agreed to by the parties.

### 8. WRITTEN AGREEMENT/JUDICIAL RULING

This Agreement is the complete and exclusive statement of agreement for the use of the subject property and supersedes all prior agreements or proposals, oral or written, and all other communication between the parties relating to the subject matter of this Agreement. If any provision of this Agreement, as applied to either party or to any circumstance, shall be adjudged by the court of competent jurisdiction to be void or unenforceable, the same shall in no way affect any other provision of this Agreement or its validity or enforceability.

The CITY and the City of Newberg hereby agree to all provision of this Intergovernmental Agreement.

### EXHIBIT "B"

### SYSTEM KEYS

System keys shall never be electronically or physically beyond the control of the System Managers listed under (Exhibit "C").

System keys shall only be present in programming computers during the initial booting process of the Motorola Radio Service Software (RSS). After the RSS is operational, the system key shall be removed by the System Manager.

System key access by any Rss programs must be configured to read the system key via a floppy disk device (i.e. drive a: or b:).

System keys shall not be permitted on any hard drive device, Local or Wide Area Network.

During unsupervised programming periods, the programming computers shall be reset or turned off to electronically erase the system key from RAM.

A written record shall be kept, during the service life of the systems, of all personnel who have programmed radios using the system keys. In the event of a breach of security, either manager may request this record at any time.

### SYSTEM ACCESS

System Managers shall follow the mutually agreed regional talkgroup and unit ID number assignments.

Only talkgroups listed under (Exhibit "A") shall be programmed into any mobile, portable, control station or console [radio(s)].

Intentional use of private call operation bypassing the mutual aid talkgroups for non-official extended wide area communications is strictly prohibited.

System Managers may grant temporary access to any talkgroups for purposes of testing programming templates.

System Managers shall be notified immediately of any lost or stolen radios that have access to their respective systems.

Lost radio ID's shall never be re-used by another radio except by mutual agreement.

# SYSTEM TECHNICAL STANDARDS -EXHIBIT "B" EXHIBIT "B" PAGE #2 OF 3

Each radio shall be assigned its own unique ID. The use of the same ID in multiple radios is prohibited.

Duplicate talkgroup ID's shall be avoided whenever possible.

System Managers shall demonstrate the procedures they will use to prevent duplication of radio ID's during the cloning process.

System Managers shall provide immediate notice of system changes that may effect interoperability between the systems, (i.e. talkgroup ID assignments, announcement ID assignments, system ID'S, control channels, connect tones, failsoft talkgroup channel assignments, coverage types, emergency data system configurations, telephone interconnection, conventional hard patches, SmartZone upgrades or system environment timing parameters).

System Managers shall make every attempt to activate radio ID;s as soon as possible during the initial programming process to expedite access verification before assignments to end users. Mass activation in advance is discouraged.

A mutually agreed upon "fill in the blanks" activation work sheet shall be developed to allow either System Managers to FAX over required information that allows individual or large group activation of ID numbers in an expeditious manner. (Exhibit "D").

System Managers reserve the right to restrict access and feature sets of any radio (s) due to operator system abuse or duplicate ID detection on their respective systems.

Notification of system denial is required within 24 hours.

System Watch monitoring of the respective systems is prohibited unless approved by the other System Managers for troubleshooting purposes. All talkgroup and radio ID information shall be treated as highly confidential.

### PROGRAMMING STANDARDS

All programming personalities that allow access to either system, shall be reviewed by the other System Managers. Written approval shall be obtained <u>prior</u> to any programming.

PTT-ID and auto affiliation operation shall be required at all times.

The System Managers reserved the right to modify programming standards. Any system standards modifications shall be in writing.

# SYSTEM TECHNICAL STANDARDS -EXHIBIT "B"EXHIBIT "B" PAGE #3 OF 3

The City or the City of Newberg shall not be held responsible for reprogramming of one or all radios due to system upgrades. The System Managers shall make every attempt to minimize reprogramming interruptions to the system users. The System Managers shall notify one another 90 days in advance of any system changes that may affect interoperability in writing.

The City shall provide the City of Newberg remote dial up access to the Bureau of General Services, Communications Services Divisions local area network, for the purpose of transferring RSS data files containing programming review process.

# ORDINANCE NO. 168329

Intergovernmental Agreement with the City of Newberg for access to the City's 800 MHz Trunking Radio System. (Ordinance)

The City of Portland ordains:

### Section: 1.. The Council finds:

- 1. Portland has established a complete 800 MHz simulcast trunking radio system in anticipation that other governmental units in the area will share in the use of the system.
- 2. The City of Newberg desires to enter into an agreement with Portland to share the use of this system, on the terms and conditions set forth in the Intergovernmental Agreement, marked Exhibit A, and attached to this Ordinance.

### NOW, THEREFORE, the Council directs:

- a. The Commissioner of Public Affairs and the City Auditor are authorized to execute an Intergovernmental Agreement with the City of Newberg for access to Portland's 800 MHz simulcast trunking radio system, in substantially the form set forth in Exhibit A, attached to this Ordinance.
- Section 2. The Council declares that an emergency exists in that prompt utilization of Portland's 800 MHz simulcast trunking radio system is necessary for the public safety; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
