

SANITARY SEWER EASEMENT

In consideration of the sum of \$ _-0- and other valuable consideration, HOME INDUSTRIES, INC. , herein called Grantor, does hereby convey to the City of Newberg, a municipal corporation, hereinafter called Grantee, a perpetual and permanent easement, for the purposes of construction, installing, using, repairing, and maintaining a sanitary sewer over, under, and across the following real property: See Exhibit "A" Attached

TO HAVE AND TO HOLD said easement to said Grantee, for the use and purpose hereinabove described.

It is further understood that:

- 1. The Grantor(s) hereby release(s) the City of Newberg, its agents and employees, assigns and successors of any and all liability for damage to the remaining lands resulting from this conveyance and construction and maintenance of said easement.
- 2. The rights granted herein shall not be construed to interfere with or restrict use of the premises by Grantor(s), their heirs or assigns, with respect to the construction and maintenance of property improvements along and adjacent to the premises herein described, so long as the same are so constructed as to not impair or interfere with the use and maintenance of access of utilities hereinabove authorized.
- 3. The Grantee hereby agrees to restore the easement to its original condition, as close as is practical to do so, upon completion of the construction.

THIS INSTRUMENT WILL NOT ALLOW USE OF THE PROPERTY DESCRIBED IN THIS INSTRUMENT IN VIOLATION OF APPLICABLE LAND USE LAWS AND REGULATIONS. EXHIBIT "A"

An easement 25 foot in width running the entire South boundary of the following described property:

A tract of land in the Southeast Quarter of Section 19, Township 3 South, Range 2 West of the Willamette Meridian in Yamhill County, Oregon, more particularly described as follows:

Beginning at a 5/8" iron rod set at the Northwest corner of that tract of land conveyed to Carita Ann Turner, et al. by deed recorded July 6, 1977 in Film Volume 121, Page 965, Deed and Mortgage Records of Yamhill County, Oregon; and running thence North 89°48′29" East along the North line of said tract, a distance of 118.75 feet; thence South 1°43′21" East, parallel with the West line of said tract, 80.3 feet, more or less, to a point on the South line of said tract; thence South 89°48′29" West, along the South line of said tract, 118.75 feet to the Southwest corner thereof; thence North 1°43°21" East along the West line of said tract, 80.03 feet, more or less, to the place of beginning.
