I understand that there are other towing companies on this list, and that I will be notified on a rotational basis.

The following are the requirements set forth by the Newberg Police Department for all companies included on the non-preference towing list:

- A) Meet all requirements by DMV (Oregon Vehicle codes 822.200, 822.205, 822.310, 822.215, 822.220, and 822.225) attached
- B) Show proof of liability insurance
- C) Maintain a secure storage lot
- D) Carry flares
- E) Be equipped with emergency overheads
- F) Carry debris cleanup equipment (broom, scoops, etc.) and agree to clean up the accident scene
- G) Provide 24-hour service
- H) Provide 10-minute response, 15 minute response from midnight to 6 a.m.
- I) Agree to store all towed vehicles unless otherwise directed by this agency
- J) Agree to include NPD case numbers on all tow slips where applicable

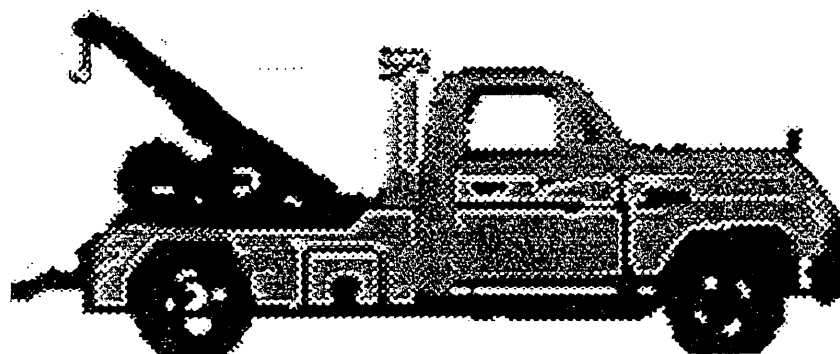
