## ORDINANCE NO. 1771

WHEREAS, a public hearing has been set for the 3rd day of March, 1975, at the hour of 7:30 P.M. at the Council Chambers of the City of Newberg in the City Hall, Newberg, Yamhill County, Oregon as the time and place for hearing and considering written objections and remonstrances, if any, against proposed vacation of that portion of Garfield Street, from the South line of Franklin Street, Southerly to the North line of the Southern Pacific Railroad property.

WHEREAS, due and regular notice of such hearing has been given by posting and by publication in the Newberg Graphic, a newspaper of general circulation printed and published in the City of Newberg, Yamhill County, State of Oregon, said posting and publication having been completed in the manner and during the time required by law, and proof thereof having been filed with the Recorder of said City of Newberg; and

WHEREAS, the Council of the City of Newberg duly met in a regular meeting of the Council, at the time and place for said hearing, for the purpose of hearing and considering written objections and remonstrances as aforesaid, and no such objections or remonstrances have been made or filed against said proposed vacation; and

WHEREAS, Preston L. Petty is the only owner of real property abutting said street so proposed to be vacated, and he has heretofore filed his written request and petition that said street be so vacated; and

WHEREAS, the said portion of Garfield Street is a dead end street and not necessary for the movement of traffic within the City of Newberg, and the petitioning property owner is the only owner who could need or use said street for access or travel; and

WHEREAS, it is for the best interest of the people of the City of Newberg, Oregon, that the above described street so proposed to be vacated, should be vacated; and

WHEREAS, there are no utilities, pole lines or sewer lines belonging to the City of Newberg, or held under franchise from said City in the said street hereby proposed to be vacated; and

WHEREAS, the Planning Commission of the City of Newberg, Oregon has heretofore recommended to the Council of the said City that said street should be vacated; and

WHEREAS, the Council has duly considered such vacations and is now fully advised in the premises.

NOW, THEREFORE, in consideration of the premises, the City of Newberg ordains as follows:
