

THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY, OREGON ("the Board") sat for the transaction of county business in formal session on February 18, 1999, commissioners Robert Johnstone and Ted Lopuszynski being present, commissioner Thomas E.E. Bunn being excused.

THE BOARD MAKES THE FOLLOWING FINDINGS:

- ORS 373.270 governs the transfer of jurisdiction over county roads within cities. The City of Newberg has requested the county to initiate a process to surrender jurisdiction over portions of the following county roads within the city: Villa Road, Deborah Road, Douglas Road, Springbrook Way, East Second Street and East Third Street ("the subject roads"). A copy of the city's request is attached as Exhibit "A."
- By Board Order 99-044 on January 21, 1999, the county initiated a process to B. surrender jurisdiction over the subject roads to the City of Newberg. In accordance with ORS 373.270(2), public notice of a hearing on February 18, 1999 was posted in three public places within Yamhill County. A copy of the county's Public Notice and Certification of Posting is attached to this Board Order as Exhibit "B."
- C. A public hearing was held in Room 32 of the Yamhill County Courthouse on February 18, 1999 on the proposed transfer of jurisdiction. The question before the Board was whether a transfer of jurisdiction over the subject roads was necessary, expedient or in the best interest of the county. No testimony opposed to the proposed transfer of jurisdiction was received.

D. Based upon the record of the public hearing and the request of the City of Newberg, the Board finds that a transfer of jurisdiction over the subject roads to the City of Newberg is in the best interest of the county. NOW, THEREFORE,

IT IS HEREBY ORDERED BY THE BOARD AS FOLLOWS:

1. Yamhill County hereby offers to surrender jurisdiction over those portions of the following described public roadways ("the subject roads) to the City of Newberg, Oregon:

NAME OF ROAD	PORTION OF ROAD AFFECTED
Villa Road	South line of Haworth Avenue to 920 feet south at the north line of Villa Homes Addition.
Deborah Road	Highway 99W to the south line of Douglas Avenue.
Douglas Road	West line of Deborah Road to the east line of Springbrook Way.
Springbrook Way	Its intersection with Springbrook Road to the south line of the Solomon Heater D.L.C.
East Second Street	East line of Everest Road to the south line of Highway 219.
East Third Street	East line of Everest Road to the south line of Highway 219.

- 2. Upon the City of Newberg's enactment of appropriate municipal legislation accepting the county's offer to surrender jurisdiction, and in accordance with ORS 373.270(7) (1997 replacement part), the offer shall be deemed accepted with the following effect:
 - a. The jurisdiction of the county over the subject roads or for their improvement, construction or repair shall cease.
 - b. The full and absolute jurisdiction over the subject roads for all purposes of repair, construction, improvement and the levying and collection of assessments therefor shall vest in the City of Newberg.

c. The City of Newberg shall have the same jurisdiction over the subject roads as by its charter and the laws of the state are given or granted it over any of the public streets and alleys of the city.



NOTICE IS HEREBY GIVEN that the Yamhill County Board of Commissioners ("the Board") will hold a public hearing on Thursday, February 18, 1999 at 10:00 a.m. in Room 32 of the Yamhill County Courthouse, 535 NE Fifth Street, McMinnville, to consider a request by the City of Newberg for the County to transfer jurisdiction to the City over of certain county roads located within city limits. The hearing is required and authorized by ORS 373.270.

The portions of roadways being considered for surrender of jurisdiction by the County to the City are described below:
