PUBLIC SIDEWALK EASEMENT

CITY RECORDER INDEX NO. 762

In consideration of the sum of \$0.00 and other valuable consideration, Providence Health System in Oregon dba Providence Newberg Hospital ("Providence Newberg Hospital"), herein called Grantors, do hereby convey to the City of Newberg, a municipal corporation, hereinafter called Grantee, a perpetual and permanent easement, for the purposes of constructing, installing, using, repairing, and maintaining a concrete sidewalk across the following described real property:

TO HAVE AND TO HOLD said easement to said Grantee, for the use and purpose herein above described.

It is further understood that:

1. The Grantor(s) hereby release(s) the City of Newberg, its agents and employees, assigns and successors of any and all liability for damage to the remaining lands resulting from this conveyance and further absolves the Grantee from any damage not controlled by their actions.
2. The rights granted herein shall not be construed to interfere with or restrict use of the premises by Grantor(s), their heirs or assigns, with respect to the construction and maintenance of property improvements along and adjacent to the premises herein described, so long as the same are so constructed as to not impair or interfere with the use and maintenance of access of utilities herein above authorized.
3. The Grantee hereby agrees to restore the easement to its original condition, as close as is practical to do so, upon completion of the construction.

THIS INSTRUMENT WILL NOT ALLOW USE OF THE PROPERTY DESCRIBED IN THIS INSTRUMENT IN VIOLATION OF APPLICABLE LAND USE LAWS AND REGULATIONS. BEFORE SIGNING OR ACCEPTING THIS INSTRUMENT, THE PERSON ACQUIRING FEE TITLE TO THE PROPERTY SHOULD CHECK WITH THE APPROPRIATE CITY OR COUNTY PLANNING DEPARTMENT TO VERIFY APPROVED USES.

Legal Description
Sidewalk Easement

A strip of land in the Daniel D. Deskins D.L.C. No. 54 located in the Northwest One-Quarter of Section 20, Township 3 South, Range 2 West, of the Willamette Meridian, City of Newberg, Yamhill County, Oregon, more particularly described as follows:

Commencing at a brass disk monumenting the Northeast Corner of the Daniel D. Deskins D.L.C. No. 54; thence along the East line of said D.L.C. S 00°17'29" W 1788.70 feet to a point, said East line being coincident with the centerline of Villa Road (County Road No. 208); thence N 89°42'31" W 20.00 feet to the **Point of Beginning**, said point being on the westerly right-of-way line of said road when measured 20.00 feet at a right angle from the centerline; thence along said right-of-way line S 00°17'29" W 74.06 feet to a point; thence N 89°36'47" W 12.50 feet to a point; thence N 00°17'29" E 73.99 feet parallel with the said right-of-way line to a point; thence S 89°57'05" E 12.50 feet to the **Point of Beginning**.
