
SUBJECT: Transfer to City of Newberg Files 6468 501 & 6468 502

A parcel of land lying in Lots 6 and 7, Block 13, CENTRAL ADDITION, Yamhill County, Oregon and being a portion of that property described in that deed to K. C. Renne and Velma G. Renne, recorded in Film Volume 99, Page 489, Records of Yamhill County; the said parcel being that portion of said property lying Northerly of a line parallel with and 10.050 meters Northerly of the "H" center line of the relocated Pacific Highway West which center line is described as follows:

Beginning at Engineer's center line Station "H" 25+560.826, said Station being 22.498 meters South and 910.863 meters East of the Northwest corner of the JOSEPH B. RODGERS D.L.C.
