RESOLUTION 49-12

WHEREAS Claude B. Cummings and Leona M. Cummings, husband and wife, and Silas W. Wallace and Charlotte J. Wallace, husband and wife, are all of the owners of the real property abutting on a portion of Third Street in the City of Newberg, Yamhill County, Oregon, which said portion of Third Street is more particularly described as follows, to-wit:

All of that portion of Third Street,
a street in the City of Newberg,
Yamhill County, State of Oregon,
lying between blocks 7 and 18 of
the Original Town of Newberg, Oregon.

and

WHEREAS all of the aforesaid property owners have heretofore filed with the Recorder of the City of Newberg, a written Petition and request that the aforesaid portion of Third Street be vacated; and

WHEREAS the aforesaid portion of Third Street is unimproved and is a dead-end street and on the edge of a deep swale and said portion is not necessary for the use of the people of the City of Newberg as a street or for traffic and it would be for the best interests of the people of the City of Newberg that said portion of Third Street be vacated, now, therefore,

IT IS HEREBY RESOLVED by the Council of the City of Newberg:

1. That the Council of the City of Newberg, pursuant to the provisions of Chapter 259, Oregon Laws, 1931, does hereby propose to vacate the following described portion of Third Street, a street in said city, to-wit:

All of that portion of Third Street
a street in the City of Newberg,
Yamhill County, State of Oregon,
lying between blocks 7 and 18 of
the Original Town of Newberg, Oregon

2. That the 6th day of September, 1949, at the hour of

7:30 o'clock P.M. on said day be, and the same hereby is, set as the time, and the Council Rooms of the City of Newberg, in the City Hall, Newberg, Yamhill County, Oregon, be, and the same hereby is, set as the place, for the hearing and consideration of written objections or remonstrances, if any, against said proposed vacation of the above described portion of Third Street.

3. That the Recorder be, and he hereby is, authorized and directed to give notice in the manner required by law of the Council's intention to vacate the above described portion of Third Street by publishing notice once each week for four consecutive and successive weeks in the Newberg Graphic, a newspaper of general circulation, printed and published in the City of Newberg, Yamhill County, Oregon, and by posting, or causing to be posted, copies of said notice at or near each end of said portion of Third Street proposed to be vacated, and in at least two conspicuous places within such proposed vacation, said notice to contain a description of the portion of Third Street proposed to be vacated, the date of this Resolution, and the time and place for the hearing by the Council of written objections and remonstrances, if any.
