General Comment - Please review the names designated throughout the RD/RA Work Plan and Design Plan, so the plans correlate to the information in the RD/RA Work Plan and are consistent throughout the document. Currently, there are multiple names for Waste Area 1, including Open Space Tract E, Tract E Open Space, Former Solid Waste Disposal Area (FSWDA) and Tract "B" and "E". A different set of names is used for Waste Area 2. This is confusing for individuals not familiar with the site.

Restoration only appears to consist of seeding following construction. The drawings reference the stormwater trench line as a swale. Please provide additional details for the restoration, including a planting plan, if applicable and, at a minimum, a seed mix and application rate for the hydroseeding.

Specific Comments:

- Section 3.1.1. Fill reused on-site should meet the State's Clean Fill Standards. Material brought to the site for fill is subject to DEQ's review for approval, regardless of the source.
- Section 3.1.3. The Grading, Erosion & Sediment Control Details (Sheet C038) is not included in the design drawings as indicated.
- Section 3.2.2. Please include restoration in this list of activities slated for the FSWDA.
 - o First bullet Sheet C166 does not apply to this section related to FSWDA activities.
 - Second Bullet Figure 4 does not apply to this section related to FSWDA activities.
 - o Third Bullet Where is the "revised grading plan" provided as referenced here?
 - o Fourth Bullet Please replace "Figure X" with appropriate reference.
- Section 3.2.3 Please update this section for the USWDC with the correct references, similar
 errors in references are shown in this section as indicated above for Section 3.2.2. Specifically,
 Sheet 165 is not related to the USWDC. This section also references a "revised grading plan,
 which is not apparent in any of the documents submitted to DEQ for review. Also, please include
 information related to restoration of this area following the earthwork activities to address the
 bare soil or reference Section 3.3.
- Section 3.3. The second bullet of this section is not clear, "seeding prepared, exposed soil
 areas". Other post-construction tasks also include removing temporary BMPs and closing out
 permits; completing a final construction survey to document site conditions, and preparing asbuilt drawings for reference during annual inspections.
- Section 3.4. Please check spelling in this section Through vs. Thought. Please include Construction Summary Reporting as component of post-construction schedule.
- Section 6.0. Imported fill requires a submittal of the source to Kevin Dana for his review for approval, regardless of whether the source is commercial or not. All fill reused on the site must meet DEQ's Clean Fill Standards.
- Section 15. Waste sampling, for waste soil and water, to determine disposition may also be required and should be identified in this section. As indicated in comments to Section 6. DEQ review for all fill sources is required. Material density/compaction testing is also required to meet the design criteria.
- Section 16. A final completion survey will be required to document the As-built elevations and to verify the final remedial action meets the design criteria/design grades.
- Section 20. Monthy field reports should also identify any problems encountered and/or deviations from the work plan and proposed or implemented resolution for any problems/changes encountered. The final construction completion report should consist of a

compilation of the monthly reports as well as all sample results collected as part of the remedial action work.

First (and least important), I wasn't anticipating placing warning signs around the solid waste disposal cell in the transmission line right-of-way. It's very unlikely that any digging or construction will be conducted atop the disposal cell, and adding warning signs would bring unnecessary attention to a small area that should just be left alone.

Second, it looks to my non-engineer eye that you're just planning on wrapping silt fences around the Hankey Road culvert to control erosion during construction in the gully. We'll see what the construction storm water permit (NPDES 1200-C) requires, but I was anticipating that the spring water and stormwater runoff would need to be directed through a filtration medium at the culvert to reduce or eliminate suspended sediments from entering Milton Creek.

Third (and most important), I see that "ENW anticipates that most if not all of the landfilled debris removed while regrading the steep slope, relocating the storm water drainage, and trenching of the expanded public storm water line will be consolidated in areas of the ravine designed to be increased in grade." I don't agree with that approach. Landfilling solid wastes in a waterway (which is what the gully is) is not allowed under current environmental laws, and in an ideal situation all of the solid wastes would be removed from the gully and the gully restored to its natural state. DEQ agreed not to require this due to the excessive costs of such a remedy, but I believe we have been clear that DEQ would like to see as much "accessible" solid waste removed from the gully as possible. If solid waste is being dug up, it should be removed from the site and properly disposed of, not placed back into the gully.
