**Action:** Adoption of Resolution No 2024-07-09-020 Contract for Lane Transit District Amalgamated Transit Union Division No. 757 – Public Safety Officers, Effective July 1 2024 – June 30 2028

**Agenda Item Summary:** The Lane Transit District and Amalgamated Transit Union, Division No. 757, Public Safety Officers agreement ended June 30 2024. Following a successful good faith negotiation as required by law, we are requesting adoption of a new agreement dated July 1, 2024 to June 30, 2028. Key provisions of the contract are:

- A new salary scale with a 25% wage increase in the first year, followed by 5%, 4% and 3% increases in succeeding years
- Added a Lead Public Safety Officer (PSO) scale at 5% above the standard wage scale
- Increased the annual shoe allowance for \$85 to \$200
- One additional floating holiday (total of three), and placed Juneteenth into the scheduled holidays
- Added a provision for a minimum of 8.5 hours off between regularly scheduled shifts
- Agreed to facilitate a payroll deduction for ATU-COPE, the transit worker focused Political Action Committee

**APPROVAL OF THE CONTRACT BETWEEN LANE TRANSIT DISTRICT AND THE AMALGAMATED TRANSIT UNION DIVISION NO. 757 – PUBLIC SAFETY OFFICERS**

**WHEREAS**, Lane Transit District and Amalgamated Transit Union, Division No. 757 (“ATU”), agreement ended June 30, 2024. Lane Transit District and ATU successfully and in good faith negotiated a new Collective Bargaining Agreement for public safety officers effective July 1, 2024 to June 30, 2028;

WHEREAS, the ATU ratified the new contract for July 1, 2024, through June 30, 2028, on Friday, June 28, 2024;

**NOW, THEREFORE, BE IT RESOLVED**, the Lane Transit District Board of Directors approves the Collective Bargaining Agreement between Lane Transit District and the Amalgamated Transit Union No. 757 – Public Safety Officers, effective July 1 2024 – June 30 2028.
