8.3. Waste Management rate increase proposal

Waste Management employees approached City Council to discuss financial operations and a rate increase proposal. In 2022, they had a rate of return of 11.8%, and in 2023 had a rate of return of 6.74%. In 2024, they anticipate being around 6.57%. They're proposing a rate increase of 3.83% to help cover increased recycling costs and helping pay drivers wages. Councilor Kilburg asked about the approved rate increase last year, which was 4.7%. Councilor Kilburg mentioned inflation's impact on Newberg residents and asked about reducing the reasonable rate of return from 11 – 13% to 8%. The Waste Management employees are returning during the next meeting, at which time councilors will vote on the rate increase.
