1. PLEDGE OF ALLEGIANCE, ROLL CALL, AGENDA UPDATE

Mayor Lauer called the meeting to order at 7:00pm.

- **ABSENT:** Councilor Wittren (excused).
- **STAFF:** Ray Young, City Manager; Sarah Skroch, City Recorder; Ed Trompke, City Attorney; Erich Mueller, Finance Director; Erika Palmer, Community Development Director; Travis Hultin, Public Works Director and Dakota Meyer, Associate Planner.

Mayor Lauer asked for agenda updates.

Ray Young, City Manager, replied the only update is the request from Emilio Inc. is not going to be on tonight because of an illness and they can't make it.

2. **PUBLIC COMMENT:** Public comment on non-agenda and consent agenda items is welcome at this time.

Shelby Staffenson, Troutdale resident, she is following up about the issue with the 257th proposal on the road and narrowing the lanes and adding crosswalks. She asked if a letter was sent to Senator Gorsek.

Ray Young stated the letter was sent to Senator Gorsek and he will follow up with him.

4. **PROCLAMATION:** Public Works Week

Mayor Lauer read the proclamation for Public Works Week.

5. REQUEST: A request from Emilio Inc. for the City of Troutdale to sponsor the Run for Red event on June 15th and the Community Health Fest on August 3rd.

Unable to attend. May try to reschedule for June 11th.

6. **REPORT:** Annual Report from the Port of Portland.

Emily Bower, Port of Portland Senior Manager Equitable Development; Chris Damgen, Port of Portland Development Manager and Sheree Temple, Port of Portland Intergovernmental Issues Manager made their introductions and presented a PowerPoint (attached as Exhibit A).

Councilor Wunn stated he doesn't know if the airport is underutilized or not, but he works in Aurora and the airport there has really taken off with the building hangars. He asked if there's a limitation on what Troutdale can do with its airport being Port owned. It seems empty out there.

Emily Bower stated the limitations are driven by the FAA. Part of it is timing and feasibility and now is not a good time to build new.

Councilor Ripma asked if the Gresham Vista Business Park property is Port property.

Emily Bower stated yes, it was purchased in 2011. It's almost built out with only a couple of lots remaining.

Mayor Lauer opened public comment at 7:30pm.

Shelby Staffenson stated she wants to encourage the airport to be viable and continue to be an airport.

Mayor Lauer closed public comment at 7:31pm.

7. **RECONSIDERATION OF A RESOLUTION:** A resolution of the Troutdale City Council declaring it's support of the \$150,000,000 Bond Measure to upgrade levees, water pumps, and natural floodplain restoration, brought by the Urban Flood Safety and Water Quality District, Measure 26-243.

Councilor White stated he met with a Sandy Drainage District member and his original no vote was that he didn't like how Troutdale got to the levee situation. He thinks Council should support the bond. It's a matching bond with \$100 million that the City will miss out on if it doesn't pass.

Councilor Ripma stated he is the City's representative on the UFSWQD. He stated the GO Bond is being levied throughout the district to fund capital projects that are definitely needed. The levee system now is 100 years old and there are needed capital improvements.

Councilor Wunn stated he doesn't support it. There are lots of things coming down the pipeline for citizens and those asks are important. He's still a no vote.

Mayor Lauer stated he will support it. The system is old and the demand on it is increasing. He's not in favor of more taxes but the citizens rely on the safety and efficiency of the levee system.

Councilor Glantz stated she is sticking with her yes vote.

Councilor Caswell stated she supports it. It's the responsible thing to do.

Mayor Lauer opened public comment at 7:40pm.

Paul Wilcox, Troutdale resident, stated his issue is with the resolution, not the bond itself. He thinks it's inappropriate for the Council as a body to be taking a position on a ballot measure, either for or against it. He doesn't recall Council endorsing the old City Hall bond. If any individual member of Council wishes to support or not support the bond, they would be welcome to submit a voters pamphlet statement, which he didn't see anybody do.

Mayor Lauer closed public comment at 7:42pm.

- MOTION: Councilor Ripma moved adoption of the resolution of the Troutdale City Council declaring it's support of the \$150,000,000 Bond Measure to upgrade levees, water pumps and natural floodplain restoration, brought by the Urban Flood Safety and Water Quality District, Measure 26-243. Seconded by Councilor White.
- VOTE: Mayor Lauer Yes; Councilor White Yes; Councilor Glantz Yes; Councilor Ripma – Yes; Councilor Caswell – Yes and Councilor Wunn – No.

Motion passed 5-1.

8. **PUBLIC HEARING / ORDINANCE (Introduction):** An ordinance adopting text amendments to Chapter 3 and Appendix A of the Troutdale Development Code.

Dakota Meyer, Associate Planner, gave a brief overview of the staff report and presented a PowerPoint (attached as Exhibit B).

Mayor Lauer asked if there are any applications causing this to be brought forth.

The reason this is being brought forward is to close out the Metro grant. The City has received a number of extensions on the grant, and it needs to be closed out.

Mayor Lauer asked if Council doesn't approve this, will the City lose the grant money.

Dakota Meyer replied, no, the money has been received and it has been spent. This is just closing out the process.

Councilor Glantz stated that in some of the planning meetings as a commissioner, she doesn't think anyone ever agreed on what the outcome of this should be. She feels like the opportunity and taxpayer money was wasted.

Mayor Lauer opened the public hearing at 8:05pm.

Paul Wilcox reiterated that the Planning Commission vote was 6-0 but the staff report says 6-1.

Tanney Staffenson, Troutdale resident, stated he is speaking as a private citizen. This has gone on for several meetings. It's a little frustrating because the Planning Commission has all commented on things they would like to see changed or edits or be able to work on and this all came back in the form of text amendments. He stated that text amendments are probably not the best way to get things the way that you want them. It's better to involve more people. There are a lot of things that are things that he would like to glean out but other then there are other things that he doesn't know why they are in there. There are parts that are not consistent with the Town Center Plan at all.

Mayor Lauer closed the public hearing at 8:08pm.

Mayor Lauer stated that staff and the Planning Commission recommend not passing this ordinance.

9. PUBLIC HEARING / ORDINANCE (Introduction): An ordinance amending Municipal Code Section 15.12 pertaining to updated State Fire Code.

Ray Young gave a brief overview of the staff report. He stated Gresham Fire Department was at a Council meeting a little while ago to discuss a few items and one of them was to update the code to reflect the current state fire code.

Councilor Glantz asked if there is a timeline. She feels that some of it could be rewritten to be clearer.

Shawn Durham, Gresham Fire Department Fire Marshall, stated that the information is the same information that the State of Oregon recommended. The language has been adopted in other cities as recommended by the State of Oregon.

Mayor Lauer opened the public hearing at 8:14pm.

Tanney Staffenson asked if you are required to have an in-home inspection if you have an in-home business.

Shawn Durham replied, no, they do not inspect businesses in residential single-family homes.

Mayor Lauer closed the public hearing at 8:18pm.

11. COUNCIL COMMUNICATIONS

Councilor Glantz stated she has been working a lot on EMCTC and she is also on the LOC Policy for State Transportation. She is trying to represent everyone in every instance. There are more dollars needed and more focus on improvement and maintenance rather than new projects.

Councilor White stated that the last weekend there was a near drowning of an 11-yearold and a 13-year-old in the chutes. He reminded everyone that the lifeguards don't start for a few weeks and wear life jackets in the water.

Mayor Lauer stated it's coming up on Public Works Week and he thanked Erika Palmer for all the work that is done at the City, and everything done in regard to Community Development and Public Works.

Councilor Wunn stated that Troutdale has fantastic Public Works workers. He stated there were many river rescues the past weekend. The water is not warm, and you won't last long. Wear a life jacket.

Councilor Ripma wished everyone a Happy Memorial Day holiday.


