## AN APPROPRIATION RESOLUTION FOR PARKS OPERATION FUND #158

WHEREAS; Council authorized a grant agreement with the Oregon Department of Transportation (ODOT) in 2023 to commit \$96,696.11 in matching funds toward an Oregon Community Paths program grant to add lighting along the Riverwalk between the Mill Pond Trestle and 35<sup>th</sup> St., and

WHEREAS; ODOT has notified that a balance of \$63,549.93 is due from the City to support its portion of the construction phase of the light installation project, and

WHEREAS; The FY2024-25 budget includes contingency funds in Parks Operation Fund # 158 to cover capital and operational expenditures outside of predicted expenses, and

WHEREAS; ORS 294.338(2) provides guidance to move funds from a contingency to satisfy an occurrence or condition that could not have been foreseen at the time of budget preparation, and

WHEREAS; a resolution authorizing the increase of appropriations within the Parks Operation Fund # 158 is required after adoption of the FY 2024-2025 budget.

WHEREAS; the adjusted budgets are on file in the office of the Director of Finance and Administrative Services at City Hall.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ASTORIA:
