AGREEMENT

This agreement is made between the City of Newberg, Yamhill County, Oregon, a municipal corporation of the State of Oregon, hereinafter called "City" and Francis Enterprises Inc.

- WHEREAS, On April 19, 1990 Francis Enterprises, Inc. received approval of a conditional-use permit from the Newberg Planning Commission to replace the movie screen at their drive-in theater (tax lot 3216-2200); and
- WHEREAS, The Planning Commission approved the conditional-use permit with the condition that Francis Enterprises dedicate the south 30 feet of the drive-in theater property for the future extension of Hayes Street; and
- WHEREAS, Drive-in facilities including fencing, landscaping, radio sound wiring, drainage tiles, paved parking, and paved access drives currently exist within the said 30 ft. wide dedication for Hayes Street; and
- WHEREAS, It is the City's intention to allow said drive-in facilities to encroach within the dedicated Hayes Street right-of-way until such time that Hayes Street is improved or the drive-in redevelops for another permitted use.

IT IS HEREBY AGREED AND UNDERSTOOD THAT:

- Section 1. The City will allow the existing drive-in facilities including fencing, landscaping, radio sound, wiring, drainage tiles, paved parking and paved access drives to encroach upon the dedicated right-of-way for Hayes Street provided that the drive-in continues to operate and until Hayes Street is improved.
- Section 2. The City will permit routine maintenance and repair of existing drive-in facilities by Francis Enterprises, Inc. within the Hayes Street right-of-way.
- Section 3. Provided the drive-in continues to exist and operate at the time Hayes Street is improved, the City agrees to remove drive-in facilities that exist within the Hayes Street right-of-way and replace those facilities on Francis Enterprise, Inc. property. Facilities to be replaced include fencing, landscaping, radio-sound wiring, drainage tiles, and paved access drives which are altered or destroyed as a result of the Hayes Street improvement. An access drive from the drive-in to Hayes Street will be provided.
- Section 4. Redevelopment of the subject site for a use other than a drive-in theater shall void the agreement for the replacement of structures

by the City and permitted encroachment of drive-in facilities within the right-of-way. Further, the encroaching structure shall be removed by the developer at their expense upon redevelopment.

Section 5. All assessments for the development of Hayes Street shall be deferred until such time that the drive-in use is discontinued and is replaced by another use permitted in the zoning district.

Section 6. Francis Enterprises, Inc. shall dedicate certain properties to the City for street right-of-way purposes as evidenced by the attached deed marked as Exhibit "A" and incorporated by this reference.

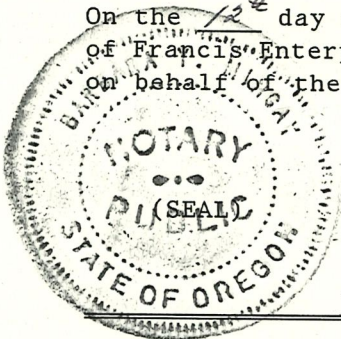

KNOW ALL MEN BY THESE PRESENTS, That Francis Enterprises, Inc., hereinafter called the Grantor, does hereby dedicate, grant and convey to the City of Newberg, a Municipal Corporation of the State of Oregon, hereinafter called the Grantee, for dedication of additional right-of-way, the following described real property located in Yamhill County, State of Oregon, to-wit:

A tract of land in the Richard Everest Donation Land Claim No. 52 in the Southwest quarter of Section 16, Township 3 South, Range 2 West of the Willamette Meridian in Yamhill County, Oregon described as follows:

Beginning at a point that is on the East line of the Everest Donation Land Claim 1054.03 feet North of the Southeast corner of the North half of said Donation Land Claim, thence S 76°46'05"W 30.86 feet to an iron rod said point being the TRUE POINT OF BEGINNING; thence S 76°46'05"W 507.67 feet to a 5/8" iron rod; thence N0°06'E 30.83 feet to a point; thence N76°46'05"E 507.62 feet to a point on the West line of Springbrook Road being 30.00 feet West of the East line of the Donation Land Claim; thence South along the West line of said road 30.86 feet to an iron rod and the point of beginning.

Said tract of land containing .35 acres of land more or less.

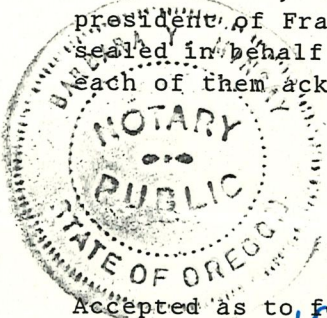
