4. PRESENTATIONS

4.1. Overview of Projects' Timeline in Urban Renewal Plan Jim Talt

Talt presented on the status of the NURA Plan and made several recommendations for how the committee could proceed.

- 1. Proceed with the existing NURA Plan but tweak it to prioritize repairs to River Street in its entirety instead of piece by piece over the next 24 years.
- 2. Do not proceed with a scoring rubric at this time, simple focus on whether or not projects align with the current plan for the next 1-4 years.
- 3. Remove the requirement for a rubric from the NURA CAC bylaws Article 4, paragraph B.
- 4.2. City Staff Recommendations for NURA projects scheduleClay Downing / Will Worthey

6.1. Discussion of NURA projects implementation schedule and funding availability

Jim Talt introduced the discussion by reviewing his list of suggestions. There was discussion about the amount of initial funding that might be available.

- 1. Proceed with the existing NURA Plan but tweak it to prioritize repairs to River Street in its entirety instead of piece by piece over the next 24 years.
- 2. Do not proceed with a scoring rubric at this time, simple focus on whether or not projects align with the current plan for the next 1-4 years.
- 3. Remove the requirement for a rubric from the NURA CAC bylaws Article 4, paragraph B.

6.2. Overview of bonding options – Will Worthey

City Manager Worthey presented options for obtaining bonds to complete the proposed work.

The City Manager described the current scenario. He explained that NURA does not currently have the capital to obtain bonds itself. He further explained that a bond could be obtained by the City on behalf of NURA through an intergovernmental agreement.

The City Manager cautioned that this would impact the City's maximum indebtedness threshold, but would not impact future loans for the Water Treatment Plant replacement as water projects are exempt from this threshold.

The City Manager stated that this was the best NURA project funding mechanism available at this time and NURA could pay for such a bond secured by the city if both agencies agree.
