CALL TO ORDER

The meeting was called to order by Chair McNary at 4:00 p.m.

PLEDGE OF ALLEGIANCE

Museum Commission Representative Reynolds led the Pledge of Allegiance.

APPROVAL OF AGENDA

It was moved by Gleason and seconded by Eagy to approve the agenda as presented. The motion carried 4/0; Eagy, Ercole, Gleason, and McNary voting in favor, none opposed, one position vacant.

APPROVAL OF MINUTES

PUBLIC COMMENT

Richard Wolfe, 4752 Simonelli Rd, The Dalles

Mr. Wolfe referred to The Dalles Municipal Code, Section 11.12.030 The Dalles Historic Landmarks Commission. This section says:

"This Commission shall consist of six members; five of which are from the citizens at large entitled to one vote, one member of The Dalles/Wasco County Museum Commission (advisory - no vote)..."

Mr. Wolfe said it seems the Commission is supporting Pioneer Cemetery, St. Peter's Landmark, Fort Dalles Museum, The Dalles Art Center, Civic Auditorium and Waldron Drugs/Gitchell Building – and not people at large. He would like the Commission to choose people from the general public.

The railing on the park near the veterinary clinic has been broken for 40 years. It needs to be fixed.

Mr. Wolfe owns 36,000 hand-made bricks from the Tony's building. He said he is the only person that shows up. He would like to be more involved.

Chair McNary thanked Mr. Wolfe for his comments.

Mr. Wolfe said a Forest Service archeologist visited Brewery Grade. The archeologist said it is the same as what he sees in the forest. In Mr. Wolfe's opinion, the rock houses were a blacksmith shop, a wheelwright, a tollbooth and a fort. Grand central station for that part of town. It deserves to be looked at. Mr. Wolfe took a third generation high school friend, a rock mason, to that location. The friend commented the rock had been put up quickly. Mr. Wolfe believes this was due to a war with indigenous people.

This is an excellent opportunity to bring mapping to the town.

PRESENTATION

Senior Planner Cook introduced Ann Moorhead, Special Projects Coordinator. Ms. Moorhead presented a brief history of the Gitchell Building and the future light projection project, Attachment 1.

Ms. Moorhead secured funding from the Columbia Gateway Urban Renewal Agency and is now moving toward installation. The project will revitalize "ghost signs" remaining on the structure.

In response to Commissioner questions, Ms. Moorhead replied:

- The projector will use white light through colored plates.
- The projector will be mounted on one pole located in fill.
- Lewis & Clark Festival Park is closed dusk through dawn, but the projections will be visible from the parking lot, the highway, and First Street.
- The projector will be installed facing the west side of the building. The signs will fade in and out in chronological order.

Chair McNary said the community needs to be exposed to the historic beauty of that building.

Museum Representative Reynolds said Mr. Winslow's work was included in an OPB field guide.

STAFF COMMENTS

Senior Planner Cook said this is her last Commission meeting. She will pursue a Master's degree in Planning, hopefully at Portland State University. Her last day is March 15.

Director Chandler wished Senior Planner Cook the best of luck on her new adventure.

Chair McNary asked who would lead the Walking Tour. Planner Cook replied, the City of The Dalles managed the grant for the Historic Walking Tour. Sally Johnson, Director of The Dalles Art Center, will be the primary contact for the Historic Walking Tour.

Museum Representative Reynolds said Fort Dalles Museum will again be included in the cruise line's "Hop On, Hop Off" route. Commissioner Gleason did not think the Original Wasco County Courthouse was contacted regarding the route.

Director Chandler said the Blue Building [205 Washington Street] went through land use approval, and just received funding from the Urban Renewal Agency to assist in redevelopment. The Agency will provide approximately \$270,000 for façade and structural improvements, as well as payment of System Development Charges (SDCs) for an additional nine residential units.

Director Chandler will meet with Commissioner Gleason to discuss the First Street Project. After many stops and starts, the project is now on track to reconstruct First Street from Union Street to Laughlin Street. Commissioner Gleason added the railroad started as a portage railroad, from the steamboat landing down the middle of Main Street (now First Street) and up to Celilo. It was incorporated into the Transcontinental Line around 1882. The line ran down the middle of the street until 1978, when it was double-tracked and shifted to the north side of the street.

The Tony's site hazardous material has been abated and demolition is complete. The site is fenced temporarily until a development proposal is received. Staff hopes to, in April, lay out the structure of an RFP to move forward with redevelopment of the site.

COMMISSIONER COMMENTS

Chair McNary gifted the City a collection of old postcards received from the estate of Thelma Cox.

Commissioner Eagy said the lights around the Landmark were stolen; each light is over \$600 to replace.

Commissioner Gleason addressed Mr. Wolfe's concerns about the Commission shared during Public Comment. The ordinance [The Dalles Municipal Code, Chapter 11.12 Historic Resources] states the Commission will consist of representatives from the community. The Commission may not necessarily be representative of the community, but is a sample of the community willing to serve. Because we are a Certified Local Government, a portion of the Commission must be historic preservation professionals. While it may appear we have conflicts, or have multiple representations, those interests are set aside while service the Historic







INSTALLATION – INFORMATIONAL SIGNAGE




- Bronze plaque

- No sign on First Street by railroad tracks due to safety concerns


PERMANENT LIGHT FIXTURE

 Uses a custom re-designed ghost sign printed onto custom templates which are backlit to project the image onto the wall.








