#### VENDOR & EXHIBITOR AGREEMENT

THIS VENDOR AGREEMENT is made and entered into on this 30<sup>th</sup> day of July, 2024, by and between the Wasco Fair Board Fair Board, an agency of Wasco County, hereinafter referred to as "Fair Board", and Fine Designs, hereinafter referred to as "Vendor."

Whereas Vendor desires to use Wasco County fairground property for commercial use related to the Wasco Fair Board Fairgrounds such as rentals, merchandise sales and food sales; and

Whereas the Fair Board has accepted the Vendor's application and desires to set forth the term of the Agreement.

#### IT IS MUTUALLY AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS:

#### 1. GRANT OF USE

- A. The Fair Board for and in consideration of the agreements hereinafter stated, grants to Vendor for the purposes stated herein, the right, privilege, and duty to equip and operate, in the area as set forth in **Exhibit A** (the "Premises").
- B. Vendor shall only use the Premises for the provision of services as set forth in **Exhibit B** (the "Vendor Authorized Uses"). Any unauthorized use of the Premises shall be grounds for immediate termination upon notice by the Fair Board.

#### 2. USE OF PREMISES

- A. Nothing in this Agreement shall be construed to grant to Vendor an exclusive right to any portion of County Property other than Vendor's personal property. Vendor shall not by virtue of this Agreement be deemed to have become the tenant of the County, or to have been given or accorded as against the County, the right to possess the Premises, or any portion thereof. Vendor shall be deemed merely to be a licensee, permitted to enter and use the described Fair Board premises solely for the purpose of exercising the rights and privileges granted in this Agreement.
- B. Vendor shall maintain the Premises at its own expense in good condition and repair throughout the term of this Agreement. Vendor shall maintain the Premises in a clean, safe, wholesome, and sanitary condition free of trash, garbage, or obstructions of any kind. Vendor shall remedy without delay any defective, dangerous, unsafe, or unsanitary conditions.
- C. Operation of the Premises shall be conducted in accordance with all applicable all federal, state and local government statues, laws, and regulations. The Use of Premises shall comply with the Fair Board Rules and Regulations, as set forth in **Exhibit C**, which may be modified by the Fair Board orally or in writing as is reasonable and necessary to meet the intention of the Fair Board for this operation and the mission of the Fair Board.
- D. Upon any termination of this Agreement, or at any other time determined by the Fair Board Rules and Regulations, Vendor shall immediately quit the Premises and shall have \_\_\_\_ hours within which to remove all personal property. Vendor shall restore the property to a condition at least as good as existed prior to commencement of this Agreement, reasonable wear and tear excepted. Any such property not so removed shall be deemed abandoned and shall become at once property of the Fair Board.

#### 3. TERM

The term of this Agreement shall be for a period of 4 days, commencing on August 15, 2024 and ending at 5 p.m. on August 18, 2024.

#### 4. PAYMENT

Vendor shall pay a percentage of sales as outlined in Exhibit B. Payment is due by September 15, 2024.

The acceptance of late payments by Fair Board shall not be deemed as a waiver of any other breach by Vendor of any term or condition of this Agreement.

#### 5. INDEMNITY

Vendor shall indemnify, hold harmless and defend Wasco County and the Fair Board, its officers and employees, against all liability or loss, and against all suits, claims, actions, losses, costs, penalties and damages of whatsoever kind or nature based upon, caused by or arising out of the negligent acts, errors or omissions of Vendor, or violation of any statute, ordinance or regulation. Vendor shall also indemnify Wasco County and the Fair Board against all liability and loss in connection with, and shall assume full responsibility for, payment of all Federal, State and local taxes or contributions imposed or required under unemployment insurance, social security and income tax laws, with respect to Vendor employees, including any subcontractors, engaged this the performance of this Agreement.

#### 6. INSURANCE

Vendor shall provide, at its own expense, liability insurance, issued by a responsible insurance company satisfactory to the Fair Board and licensed to do business in the State of Oregon. The insurance shall afford limits of liability of \$1,000,000 per occurrence for bodily injury and property damage liability combined with \$2,000,000 annual policy aggregate to protect the Fair Board against claims for injury and damages to persons and property occurring by reason of negligent acts of Vendor. The insurance policy shall name the Wasco County and the Fair Board, its elected officials, officers, agents, and employees as additional insureds. Coverage shall be primary and non-contributory with any other insurance.

**Automobile Liability Insurance** VENDOR shall, at its own expense, maintain automobile liability insurance with combined single limit of not less than \$1,000,000 (one-million dollars) each occurrence for bodily injury and property damage including coverage for owned, hired, or non-owned vehicles.

Vendor shall provide proof of such insurance to Fair Board not less than 14 days before the scheduled commencement of this concession. Each policy shall be underwritten to the satisfaction of the Fair Board.

#### 7. ALCOHOLIC BEVERAGES

Except as approved by the Fair Board, sale of alcoholic beverages on the Premises is expressly prohibited. Violation of this section is subject to immediate termination of the Agreement at the discretion of the Fair Board.

#### 8. CONTRACT NOTICE

Any notices required to be given or that may be given by either party to the other shall be deemed to have been given when made in writing and deposited in the United States mail, postage prepaid, and addressed as follows:

Either party may terminate this Agreement for convenience with at least 30 days written notice delivered to the other party.

#### 11. ATTORNEYS FEES

If either party incurs attorney's fees (including attorney's fees incurred in any bankruptcy or administrative proceeding or in any appeal) as a result of a breach or default under the terms of this Agreement by the other, the party incurring attorney's fees shall be entitled to reimbursement. If any lawsuit is brought with respect to the enforcement of this Agreement, the prevailing party shall be entitled its reasonable attorney's fees and expenses.

## WASCO COUNTY OFFICIAL SOUVENIR MERCHANDISING AGREEMENT WASCO COUNTRY FAIR

#### FINE DESIGNS AGREES TO THE FOLLOWING:

- 1. **Commission Payment Structure:** Wasco County is paid according to the following formula for the exclusive merchandising and novelty sales:
  - 1. For events generating sales over \$30,001:

30% of Gross Sales.

2. For events generating sales between \$15,001 and \$30,000:

25% of Gross Sales.

3. For events generating sales between \$7,001 and \$15,000:

20% of Gross Sales.

4. For events generating sales between \$3,001 and \$7,000:

15% of Gross Sales.

5. For events generating sales \$3,000 and below:

10% of Gross Sales.

- 2. **Optional Donated Apparel:** We will donate up to -----15 volunteer/staff Cotton T-shirts at no cost to Wasco County for each contracted event. Donated apparel includes the Official tournament logo on front with either "Staff" or "Volunteer" wording on the back. Additional Volunteer tees will be sold at the lowest wholesale cost of ------\$8.00 per item for 100% cotton tees.

- 1. **Exclusive Souvenir Apparel:** Give exclusive distribution rights for imprinted Event logo on Designated Merchandise to Fine Designs only (no other entity will sell or give away event or sport related preprinted or customized apparel onsite; no other entity will have permission to have and/or operate a heat press onsite; no other entity will be able to customize event or sport related apparel in any way (printing, rhinestones, embroidery)) during the Event period on the premises where Even is taking place.
- 2. Named Official Event Merchandiser: Name Fine Designs the "Official Event Merchandiser" of Wasco County agreed events.
- 3. **Logo Property:** All data produced as a result of this program shall remain the sole property of the Wasco County.
- 4. **Provisions:** Wasco County is to provide prime sales location (space accommodations are to be agreed upon by both parties). Wasco County is to *use its best efforts* to provide 4 tables, electricity and tents (if applicable).

- 5. **Outside Vendors:** Wasco County agrees to seek approval from Fine Designs for any other vendors and/or suppliers to be allowed to sell any type of apparel, sports equipment, and/or novelties at any events covered as part of this partnership. The sale of the Official Event logo merchandise is exclusively limited to Fine Designs. In the event that Fine Designs grants approval, it is understood that Fine Designs will be granted its first choice of sales location(s) at each venue.
- 6. **Revenue Sharing:** If revenue sharing is required, Fine Designs shall not be responsible for providing any additional percentage or vendor fees to any third party. Wasco County will handle all responsibility and negotiations if revenue sharing is required.
- 7. **Apparel Marketing:** Wasco County agrees to properly market the onsite merchandise by sending E-mail blasts and social media plugs to promote Wasco County Official Custom Merchandise onsite. Wasco County also agrees to contribute creative ideas to promote the sales of official merchandise.
