A BUDGET AMENDMENT RESOLUTION TO RECEIVE AND APPROPRIATE LOAN FUNDING FOR THE PUBLIC WORKS CAPITAL IMPROVEMENT FUND #178

WHEREAS, ORS 294.471(1)(c) provides guidance for a supplemental budget to increase appropriations due to funds that are made available by another unity of federal, state, or local government, and;

WHEREAS, ORS 294.471 (1)(a) provides guidance for a supplemental budget due to an occurrence or condition that is not ascertained when preparing the original budget, and;

WHEREAS the City has been offered a loan from Business Oregon for the increased costs of the 8th Street Waterline Replacement Project in the amount of \$149,319, and;

WHEREAS the City accepted a loan of \$340,681 in March of 2024 for the project, \$56,980 of which was spent and reimbursed in the 2023-24 Fiscal Year, leaving \$283,701, and;

WHEREAS, a Resolution authorizing the increase of revenue and appropriations within the Public Works Capital Reserve Fund #178 is required after adoption of the FY 2024-2025 budget, and

WHERAS, the adjusted budgets are on file in the office of the Director of Finance and Administrative Services at City Hall;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ASTORIA:

Increase Loan Revenue by \$433,020 and increase appropriations in the fund by \$433,020 in Capital Outlay In Public Works Capital Reserve Fund #178.
