Dear City of Eugene:

The Oregon Department of Environmental Quality (DEQ) is providing oversight for the investigation and cleanup of a release of hazardous substances from the above referenced site. Based on our review of site information, we have determined that site conditions are protective of public health, safety and welfare, and the environment under the Oregon Environmental Cleanup Law, ORS 465.200 et seq. This determination is summarized in our Staff Memorandum in support of a No Further Action determination dated September 5, 2024. DEQ issues a no further action determination when a cleanup has met regulatory standards under Oregon's Cleanup law.

Low concentrations of gasoline, diesel, and oil-range hydrocarbons remain in portions of the site. Concentrations detected in soil and groundwater are below the risk-based concentrations for occupational, construction worker and excavation worker receptors. Groundwater contamination on the southern property exceeds the groundwater RBCs for vapor intrusion, however depth to groundwater and property zoning make this pathway incomplete. Concentrations of contaminants in soil vapor beneath the building are below the soil gas RBCs for occupational receptors.

Because your property is located adjacent to the site, DEQ is notifying you of its proposal to issue a no further action determination. Directions on how to comment on DEQ's proposal and where to find additional information are provided below.
