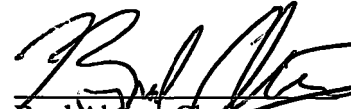
6. BUDGET PRESENTATION

7. ADJOURN

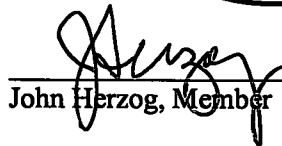
Chair Alcorn adjourned meeting at 10:06 a.m.
