# AGENDA ITEM 6A DISCUSSED AFTER AGENDA ITEM 4A AND BEFORE AGENDA ITEM 4D

A. Code Enforcement – Adoption of Warning of Violation Policy – Craig Anderson, Planning Director

Anderson spoke about giving a warning before charging double fees.

Motion by Paasch, seconded by Boice, to adopt policy presented by Anderson. Motion carried unanimously.

B. Appoint Central County Position to the Tourism and Promotions Committee – Miranda Plagge, Economic Development Assistant

Boice read the order and Plagge advised both applicants are qualified.

Motion by Boice, seconded by Paasch, to appoint Samuel Waller III to the Tourism and Promotions committee. Motion carried unanimously.

- C. Colvin Building IT Plan Wendy Lang, Juvenile Director
  Lang spoke about the need to and benefits of updating Colvin Building IT. A discussion with
  Boice, Herzog, Lang, and Paasch about considering the upgrade, costs, and funding followed.
- D. Curry County Discussion Ordinance Against "Drug Addiction Enablement Programs" Commissioner Boice

Boice gave a brief history of the topic. A discussion with Boice; Herzog; O'Sullivan; Paasch; and Tony Voudy, Veterans Service Officer, followed.

E. Appointment of Alternate ARP Fund Stakeholder Committee Member – Anthony Pope, County Counsel

Pope explained the need for the appointment.

Motion by Boice, seconded by Herzog, to fill the American Rescue Plan Committee with Hank Cunningham. Motion carried unanimously.

F. Approval of Contract Negotiation with ADAPT and Designating Authorized Signatory – Anthony Pope

Pope stated (1) he and O'Sullivan have agreed on everything, (2) he is working on drafting a contract, and (3) he is asking, once the agreement is done, for permission to have Herzog sign lease agreement.

Motion by Boice, seconded by Paasch, we want to delegate that authority, Counsel Pope, to proceed with the lease with ADAPT health care and anything you need, I think this Board has given you full approval. Motion carried unanimously.

G. Tentative 2022 BOC (Board of Commissioners) Meeting Schedule – Anthony Pope, County Counsel

Pope explained the proposed 2022 meeting schedule.

Motion by Paasch, seconded by Boice, to keep meetings on the first (1<sup>st</sup>) and third (3<sup>rd</sup>) Wednesdays of the month. Motion carried unanimously.

- H. County Finances Analysis Plans to Begin Rebuilding the Curry Financial Foundation Rob Moody Merina+Company at the Request of Commissioner Boice
   Boice gave a brief history of Merina+Company and introduced Rob Moody (via GoToMeeting),
   CPA, Partner Merina+Company. Moody introduced Jordan Henderson (via GoToMeeting),
   Professional Engineer, Project Management Professional. Merina+Company; and Courtney Seto
   Curry County Strategic Plan:

(via GoToMeeting), Consultant, Merina+Company. A lengthy discussion with David Barnes, County Treasurer; Boice; Henderson; Herzog, Paasch, and Seto about Curry County financial issues, revenues, expenses, mandatory State services, timelines, and Merina+Company costs ensued.

Motion by Boice I think this is the absolute smartest thing we can do, it is a bold step, and it is imperative we do it immediately so that we can get it to the Budget Committee by March and to accept the Merina contract for \$47,000. Motion dies for lack of a second.
