BUSINESS MEETING MINUTES

July 6, 2022

1. CALL TO ORDER & PLEDGE OF ALLEGIANCE

The meeting was called to order by Chair Herzog at 9:00 a.m. Present were Chair John Herzog, Vice Chair Chris Paasch, and Commissioner Court Boice.

Also Present: Legal Counsel Anthony Pope and Administrative Assistant John Jezuit

Herzog gave an invocation.

The Pledge was recited by all.

Boice asked for a moment of silence.

2. AMENDMENT/APPROVAL OF THE AGENDA

Paasch - Pull Agenda Item 5F as more comments need to be made. Herzog is not in favor of moving Agenda Item 5F to Discussion/Action Item. Paasch does not believe Emergency Services management should be under the guise of Commissioners. Paasch observed, if there is a County emergency, the Sheriff is the number one guy, he directs everyone from his office, and Emergency Services should be under his control. Both Boice and Herzog want to leave 5F in the Consent Agenda.

Motion by Boice, seconded by Herzog, to approve agenda as amended. Motion carried 2-1 (Boice - Yes; Herzog - Yes; Paasch - No)

- A. ODF (Oregon Department of Forestry) Fire Risk Maps for Curry County – Becky Crockett, Planning Director

A discussion with Boice and Crockett about the fire risk maps, timelines, buildable land, and insurance followed.

- B. Roadmaster Signature Authority for \$3.8M Federal Lands Access Program (FLAP) Project Memorandum of Agreement – Richard Christensen, Roadmaster
- Christensen spoke about timelines, costs, and project details.

Motion by Boice, seconded by Paasch, to approve. Motion carried unanimously.

- C. Road Department Awarded \$2M STIP (Statewide Transportation Improvements Project) Grant through the Local Agency Bridge Selection Committee for Local Bridge Program Funding. Christensen summarized details of the request, costs, and timelines.

- D. Child Care Start Up Cohort – Summer Matteson, Economic Development Coordinator
- Matteson spoke about childcare needs. A discussion with Boice, Herzog, and Matteson about costs, timelines, and deliverables followed.

E. Concept Development in Formation of a Food Council in Curry County – Summer Matteson, Economic Development Coordinator
Matteson spoke about creating a food council. A discussion with Boice, Herzog, and Matteson about core needs of a community and a possible future resolution on the subject followed.

F. Curry County Boice Cope Park – Long Term Maintenance and Improvement Planning – Commissioner Boice

Boice introduced Wendy Lang, Juvenile Director, who spoke in detail about Boice-Cope Park and Lobster Creek Park short term and long-range maintenance issues. A discussion with Boice, Herzog, and Lang about immediate maintenance priorities, the reservation system, and future plans ensued.

G. Support for Historical and Important Rogue River Seasonal Channel Maintenance – Five (5) Year Department of Environmental Quality and Oregon Division of State Lands – Commissioner Boice

Herzog called for a motion.

Motion by Boice, seconded by Paasch, per the amended letter that we put on your desk this morning that, approve that, and support this five (5) year permit. Motion carried unanimously.

H. Curry Board of Commissioners Authorizing the Transfer of One Curry Public Transit Bus - Free to Brookings Community Resource Response (Brookings Core Response) – Commissioner Boice

A discussion with Boice, Christensen, Herzog, and Paasch about which departments could use a bus and costs followed. The Board decided to table this item.

I. Curry Board of Commissioners Support for Updated-Supplemental Environmental Impact Statement – Cole Rivers Fish Hatchery – Curry Salmon Recovery Coordinator Beyerlin - Commissioner Boice

Boice summarized the issues.

Motion by Boice, seconded by Paasch, to approve this letter. Motion carried unanimously.

J. Curry County Proclamation - Opposition to the Oregon Department of Forestry Proposed HCP (Habitat Conservation Plan) – Dr. Bob Zybach Presentation - Commissioner Boice

Boice introduced Zybach (via GoToMeeting) who summarized the history of this issue and its impact on Oregon.

Motion by Boice, seconded by Paasch, that the Board approve this proclamation, Curry County proclamation, that opposes Oregon Department of Forestry's western habitat conservation plan. Motion carried unanimously.

Motion by Paasch, seconded by Boice, to amend your [the] ARS (Agenda Routing Slip) to say instead of vacating, we lease the property on Zimmerman Way immediately. Motion carried unanimously.

7. PUBLIC HEARING

A. Changes to County Fee Schedule – Anthony Pope, County Counsel

Herzog opened the public hearing, asked for public comment, and observed no members of the public were present. Pope stated fee changes were made by department heads. Garrett Thomson, Building Official, addressed the need for the fee changes. Boice stated these are hard times for people, noted we have a meeting on July 7, 2022, at 10 a.m., (so he can read it tonight, July 6, 2022), commented he does not think he will have trouble supporting it, observed he does not want to support it without wise research, and said he is just going to be a hold out.

Motion by Paasch, seconded by Herzog, to approve. Motion carried 2-0 (Herzog – Yes; Paasch – Yes; Boice – Abstain).

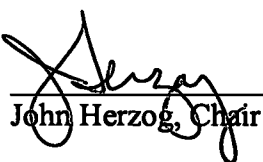
Boice asked for the Board's support to be appointed as Emergency Services Liaison.
