C. Presentation – Derek Tonn, New Director – Small Business Development Center (SBDC) – Southwest Oregon Community College - Commissioner Boice

Boice introduced Tonn who spoke about three (3) themes: (a) Regional focus (b) Housing and (c) Childcare. A discussion with Boice, Herzog, Paasch, and Tonn about SWOCC (Southwestern Oregon Community College), CCD (Coos Curry Douglas), economic development, and small businesses followed.

6. DISCUSSION/ACTION ITEMS

AGENDA ITEM 6A DISCUSSED AFTER AGENDA ITEM 6B.

A. Approve Roadmaster Signature Authority to Purchase RapidView IBAK HDTV System from SWS Equipment LLC for \$187K - Richard Christensen, Roadmaster

Christensen spoke about the advantages and benefits of the equipment. A discussion with Boice; Christensen; Shane Gutridge, Territory Sales Manager, SWS Equipment, Inc; Herzog; and Paasch about culvert inspection, possible alternatives, costs, and a request for more research followed. The Board consensus was to table this request.

B. Request to use \$600K of ARP Funds for Purchase of Twenty (20) New Vehicles for General Services Vehicle Replacement Fund — Richard Christensen, Roadmaster Christensen spoke about the advantages and benefits of the vehicle replacement fund. A discussion with Boice, Christensen, Herzog, Paasch and Sheriff Ward about costs, details, quantities, and the need for a plan followed. Christensen agreed to come to a future meeting with a list of the highest priority vehicles.

Motion by Boice, seconded by, take, that gives the Board ample time to really look into everything that's been communicated today, by (*inaudible*) and say OK we want to stay with this plan, meanwhile we've ordered the vehicles, which we're responsible to replace, and get that plan going, then we've got two (2), three (3), four (4) months to take the responsibility and study this carefully; and yes, get a plan. *Motion dies for lack of a second*.

C. Roadmaster Signature Authority to Purchase Eleven (11) New Road Department Vehicles for \$400K - Richard Christensen, Roadmaster

Christensen spoke about the details of the current fleet.

Motion by Paasch, seconded by Boice, to approve. Motion carried unanimously.

AGENDA ITEM 6D WAS PULLED

- D. Curry County Proclamation Opposition to the Oregon Department of Forestry Proposed Habitat Conservation Plan (HCP) Commissioner Boice
- E. Support Letter Request to U.S. Senator Jeff Merkley Supplemental Environmental Impact Statement for Lost Creek Lake Project Curry Commissioners Commissioner Boice Boice read parts of Steve Beyerlin's statement such as improvements in technology, failed mitigation program, loss of harvest, Cole Rivers fish hatchery, and the Coquille tribe. A discussion with Boice, Herzog, and Paasch followed.

Motion by Boice, seconded by Paasch, direct Curry County Rogue Salmon and Steelhead Recovery Coordinator Beyerlin to draft a letter and get it to our Board as soon as possible for presumptive approval. Motion carried unanimously.

F. America Rescue Plan Funds to Assist the City of Gold Beach for Curry County Veterans Memorial Maintenance - Commissioner Boice

Boice summarized the issues impacting the Memorial. A discussion with Boice, Herzog, and Paasch about including Anthony Voudy, Curry County Veteran's Service Officer, and others in the planning process; costs; and getting more details followed. Boice will move forward on the project.

G. Consumption Tax – Josephine County and Curry County Matching Plan and Efforts and Plans in Time for the November 8, 2022, General Election Ballot – Commissioner Boice Boice spoke about Josephine County's Consumption Tax plan. A discussion with Barnes, Boice, Christensen, Herzog, and Paasch about what to tax, impact on taxpayers, the Road Fund, timelines, procedures, and possibly using, with State legislature approval, TLT (Transient Lodging Tax) funds for law enforcement followed. Boice stated he has direction to proceed and will get a report back.

Motion by Boice, seconded by Herzog, through the ARP funding County totals that we appropriate, for now, up to \$50,000.00 for the Port of Gold Beach for their high dock scheduled emergency repairs. Motion caried unanimously.
