 Matteson spoke about north county supportive funding for the FBLA (Future Business Leaders of America) leadership conference in Denver, CO, the 2CJ Booster Club for Driftwood Elementary, the Cape Blanco Soccer Club, and the Cape Blanco Youth Sports Basketball.

Motion by Boice, seconded by Herzog, we do the American Rescue Plan funding for north Curry youth programs, all four (4) of them, for \$9,800.00 and [per Paasch] the FBLA leadership conference attendees report to the Board what they learned. Motion carried unanimously.
