WHEREAS, by Resolution (Court Vol 2, Page 149) of the Court dated August 9. 1967, Curry County designated property as county forest land; and

WHEREAS, the Board of County Commissioners desires to expand the boundaries of the current county forest; and

WHEREAS, ORS 275.320 allows a Board of Commissioners to, by Order, designate as county forests any real property heretofore or hereafter acquired by the county for delinquent taxes or otherwise; and

WHEREAS, on December 29, 2020 Curry County received an approximate 34.0 acre parcel along and bisected by Airport Road described as Assessor's Map 31-15-33 Tax Lot 1200 as a result of a land exchange with Oregon State Parks;

NOW, THEREFORE, THE BOARD OF CURRY COUNTY COMMISSIONERS HEREBY ORDERS that real property described as:

Tax Account No. R25698

Assessor's Map 31-15-33 Tax Lot 1200

The Southeast Quarter (SE ¼) of the Northeast Quarter (NE ¼), and the Northeast Quarter (NE1/4) of the Southeast Quarter (SE1/4) of Section Thirty-three (33), in Township Thirty-one (31) South, Range Fifteen (15) West, Willamette Meridian, Curry County, Oregon, the said parcel being described as follows:

Beginning at a point Sixty (60) feet due North of the northwestern corner of the Southeast Quarter (SE ¼) of the Southeast Quarter (SE1/4) of Section Thirty-three (33), Township Thirty-one (31) South, Range Fifteen (15) West, Willamette Meridian, Curry County, Oregon;

Thence North 1,260 feet;

Thence East 660 feet;

Thence North 660 feet;

Thence East to a point on the Westerly right of way line of the Roosevelt Coast Highway, said point being 30 feet distant from (and measured at right angles to) the center line of said highway;

Thence southerly along the westerly line of said highway to a point due east of the point of beginning.

SAVE AND EXCEPT that portion lying within the public roads.

Be incorporated into the Curry County Forest to allow for better management of the property and, therefore, the incorporation is in the best interest of Curry County;

**AND IT IS FURTHER ORDERED** that, pursuant to ORS 275.360, this Order shall be recorded in the deed of records of the Curry County Clerk.
