WHEREAS, by Resolution (Court Vol 2, Page 149) of the Court dated August 9, 1967, Curry County designated property as county forest land; and

WHEREAS, the Board of County Commissioners desires to expand the boundaries of the current county forest; and

WHEREAS, ORS 275.320 allows a Board of Commissioners to, by Order, designate as county forests any real property heretofore or hereafter acquired by the county for delinquent taxes or otherwise;

NOW, THEREFORE, THE BOARD OF CURRY COUNTY COMMISSIONERS HEREBY ORDERS that real property described as:

Tax Account No. R24625 Assessor's Map 32-15-13 Tax Lot 3400 (40 acres)

Southeast quarter (¼) Section of Southeast quarter (¼) Section, Section Thirteen (13), Township thirty-two (32) South, Range Fifteen (15) West, Willamette Meridian, Curry County, Oregon, containing forty (40) acres more or less.

Tax Account No. R18951 Assessor's Map 32-15-14 Tax Lot 3500 (10 acres)

Northeast quarter of Northeast quarter of Northwest quarter (NE ¼ NE ¼ NW ¼), Section Fourteen (14), Township Thirty-two (32) South, Range Fifteen (15) West, Willamette Meridian, Curry County, Oregon, containing ten (10) acres more or less.

Tax Account No. 19144 Assessor' Map 32-15-14 Tax Lot 3800 (20 acres)

Beginning at a point 10 chains South of the Quarter corner to Sections eleven (11) and fourteen (14), Township thirty-two (32), South of Range fifteen (15), West of the Willamette Meridian, thence South 10 chains; thence West 20 chains and 25 links; thence North 10 chains; thence East 20 chains and 25 links to the place of beginning containing twenty and one-fourth (20-1/4) acres.

Be incorporated into the Curry County Forest to allow for better management of the property and, therefore, the incorporation is in the best interest of Curry County;

AND IT IS FURTHER ORDERED that, pursuant to ORS 275.360, this Order shall be recorded in the deed of records of the Curry County Clerk.

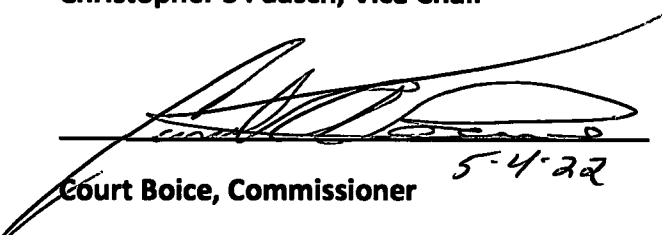

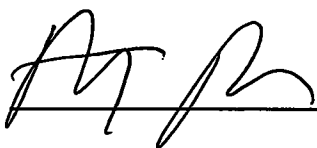
