POSITION SUMMARY:

An employee in this class will act as an advocate and provide representation and technical assistance to veterans of the United States Armed Forces in the preparation, presentation and prosecution of claims for benefits to which they are entitled under federal, state and local laws. In this position the Assistant Veterans Service Officer will specialize in assisting veterans, their dependents, and survivors in applying for and receiving benefits they may be entitled to, with a focus on representing veterans before Federal Law Judges and Decision Review Officers with the United States Department of Veterans Affairs (USDVA) in pursuit of benefits through appeals.

The Assistant VSO will represent claimants as a federally authorized representative to file claims and actions on behalf of the veterans, their survivors and dependents to ensure they receive the maximum entitlement of benefits. An Assistant VSO considers a wide range of legal, medical, occupational and other factors to develop cases based upon complicated facts. The Assistant VSO will also advise claimants on entitlements and procedures, placement and follow-up services for eligible patients to residential care facilities, homes for the aged, adult foster care homes, and financial eligibility for assistance such as food stamps for elderly, blind and disabled people.
