WHEREAS, a duly noticed Public Hearing regarding these fee changes was held on July 6, 2022.

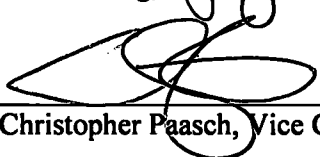
