GENERAL STATEMENT OF DUTIES:

This is a multi-disciplinary position that assists the Roadmaster by inspecting improvements to determine compliance with approved plans, contracts, standards and regulations. Performs inspections of the Road Department infrastructure as directed and related work as required.
