WHEREAS, Curry County Juvenile works with youth and provides a safe and secure environment for youth in need; and,

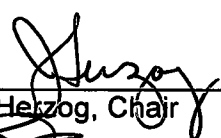
WHEREAS, Three Rivers Foundation offers grants for Curry County and the Curry County Juvenile Department applied; and,

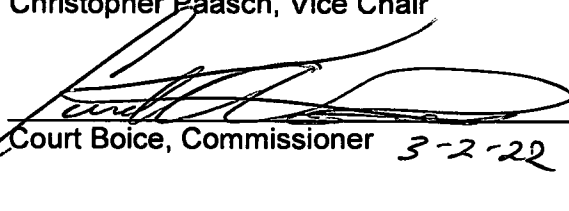

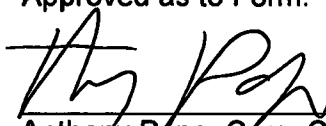

We are a small county with limited resources. We have had instances where the only safe place to temporarily house a youth, while determining appropriate resources/placement was in the back of our transport vehicles. This is disrespectful for both youth and staff, but sometimes the only current option. With the new Safe Room we can offer it to community partners as well, with the goal that any youth in crisis who needs short term safe space would be able to use this resource. We have a kitchen, bathrooms and qualified staff to work with law enforcement, homeless coalitions and others.
