### **Welcome and Meeting Open**

At 9:03 a.m., Chair Matt Donegan opened the meeting and reviewed DEQ's mission and the day's agenda.

Attendees: Chair Matt Donegan, Commissioner Karen Moynahan, Commissioner Amy Schlusser and Commissioner Mark Webb. Also present were DEQ Director Leah Feldon and Department of Justice Counsel Gary Vrooman.

The meeting was held via Zoom and in person at the DEQ Portland Headquarters (700 NE Multnomah Street, Portland, Oregon 97232) in the 3<sup>rd</sup> Floor Conference Room.

### **Item A: Draft Meeting Minutes (Action)**

Commissioners reviewed and took action on the proposed draft minutes from the May 2024 regular meeting, the July 2024 special meeting and the August 2024 special meeting.

**Action**: Approve minutes as presented of the May 2024 regular meeting, the July 2024 special meeting and the August 2024 special meeting.

## Item B: Bio-Oregon Protein, Inc. Hearing (Action)

Presenters: Erin Saylor (DEQ), Diane Lloyd (DOJ), Misha Isaak (Attorney for Bio-Oregon Protein, Inc.) The commission heard oral argument from and had an opportunity to ask questions of both DEQ and Bio-Oregon representatives regarding Bio-Oregon's Petition for the commission's review of the Administrative Law Judge's October 2023 Proposed Order regarding a National Pollutant Discharge Elimination System permit issued by DEQ to Bio-Oregon for its seafood processing facility in Warrenton, Oregon.

Commissioners asked clarifying questions regarding the permittee's interpretation of DEQ's rules and processes. Commissioners asked about the availability of technology to meet DEQ's compliance requirements. There was also discussion about if and when there was an opportunity to object to changing Administrative Law Judges. The commission then deliberated and determined by motion its decision on the Final Order in this matter.

**Action**: Uphold the Administrative Law Judge's Proposed Order supporting the Permit, with the exception of the mercury limits for Outfall 002 and 003 which DEQ has conceded and adopt it as

## Item C: Safety-Kleen Systems, Inc. Hearing (Action)

Presenters: Jeff Backman (DEQ), Gary Vrooman (DOJ), Jennifer Gates (Attorney for Safety-Kleen Systems, Inc.)

The commission heard oral argument from and asked questions of both DEQ and Safety-Kleen representatives regarding DEQ's Petition for the commission's review of the Administrative Law Judge's July 2022 Proposed Order regarding alleged violations of federal financial assurance requirements adopted by reference by the EQC, as applied to Safety-Kleen's hazardous waste treatment, storage and disposal facility in Clackamas, Oregon. Commissioner Moynahan recused herself due to prior discussions on the matter.

During deliberations, Chair Donegan clarified that the action before the commission was to interpret the rule and that the commission can revisit this and have the hazardous waste program staff and DOJ review and further clarify the rules. The commissioners discussed the confusion around the interpretation of regulations in this case. The commission voted to modify the proposed order by revising the motion language to align with item number one on page four of the staff report and reduced violations to zero. The commissioners reconfirmed that moving forward, if they modify a proposed order in any substantial manner, they must explain the modification to the parties after which counsel would be directed to draft a new order to ensure that a standard is met.

**Action**: Direct counsel to draft a Final Order of the commission consistent with DEQ's recommended interpretation of 40 CFR section 264.147A.

## Item D: Recycling Updates 2024 Rulemaking (Informational)

DEQ staff presented background information on the Recycling Modernization Act rulemaking and topics. This is the second of two rulemakings the program is conducting to implement the requirements of the Act that was passed by the Oregon legislature in 2021 (Senate Bill 582). DEQ staff will present the proposed draft rules to the commission for consideration in November 2024.

The presentation covered potential impacts of the proposed Recycling Modernization Act rule. DEQ staff also provided information to the commission on the projected financial impact of fees on processors and consumers and explained that consumer costs may not increase significantly, and organizations are working on budget estimates. There was a discussion of the agency anticipating an annual budget of about \$200 million, which is a fraction of Oregon's total waste management cost. The presentation also outlined expected ecological fees, and their adjustments based on producers' efforts to reduce environmental impact. The commissioners noted that implementing the program is a significant effort and they are proud of the national interest in similar models in other states.

## Item E: Climate Protection Program 2024 Rulemaking (Informational)

DEQ provided an update on the Climate Protection Program 2024 Rulemaking to reinstate a program establishing enforceable limits on climate pollution from the use of fossil fuels throughout Oregon. This rulemaking was prompted by a determination by the Oregon Court of Appeals that invalidated the Climate Protection Program rules that EQC adopted in late 2021. Commissioners asked clarifying questions and expressed concerns about pollution, public health, and environmental justice, urging that vulnerable communities be prioritized in climate action efforts.

At approximately 3 p.m., the commission took a short break and ended the Zoom session. Chair Donegan reconvened the meeting in a new Zoom session at approximately 3:15 p.m.

## **Welcome and Meeting Open**

At approximately 9 a.m., Chair Matt Donegan opened the meeting and reviewed DEQ's mission and the day's agenda.

Attendees: Chair Matt Donegan, Commissioner Karen Moynahan, Commissioner Amy Schlusser, and Commissioner Mark Webb. Also present were DEQ Director Leah Feldon and Department of Justice Counsel Gary Vrooman.

# Item G: Climate Protection Program 2024 Rulemaking, Continued (Informational)

This item was a continuation of Item E on the Sept. 26 agenda when the commission discussed the Climate Protection Program 2024 Rulemaking. Commissioners expressed a sense of urgency to be well-informed and prepared for the rulemaking vote in November. Commissioners commented on the Sept. 26

public hearing and noted that there was significant public support for the program as well as criticisms. Commissioners expressed support for the proposed program in general, highlighting Oregon's leadership in the area, although some said there are specific issues requiring further discussion, such as fee allocations and equity implications. Commissioners also expressed interest in ensuring that funding from Community Climate Investments is effectively managed and spent according to established guidelines while benefiting environmental justice communities.

Staff confirmed that an equity advisory council will be established to guide decisions related to greenhouse gas reduction measures that benefit diverse communities in Oregon.

There were also discussions about how funds could be allocated towards industrial decarbonization projects alongside traditional community-based initiatives like weatherization or transportation electrification. There was a focus on regulatory certainty for businesses involved in emissions reductions while maintaining accountability for achieving stated goals within the CCI program. Commissioners and staff acknowledged potential challenges surrounding the attribution of emissions reductions when multiple funding sources are involved, highlighting ongoing efforts to develop best practices around this issue. Commissioners emphasized the need to follow best practices in carbon counting and verification to build a credible program.

# Item H: Wastewater Operator Certification 2024 Rulemaking (Informational)

DEQ staff presented information on an ongoing rulemaking to update Wastewater Operator Certification requirements. The rulemaking seeks to clarify existing rules and address the growing challenge of ensuring there is a sustainable, certifiable workforce to operate and maintain Oregon's wastewater utilities. DEQ intends to propose rules to the commission for consideration at their November 2024 meeting.

Commissioners asked clarifying questions that covered workforce development in the water treatment sector, highlighting the need for better training and certification pathways for operators, especially in smaller communities. DEQ staff presented information on the composition of the Rules Advisory Committee and their efforts to ensure representation from various regions and community sizes. Discussions with the commissioners and staff touched on educational programs available at community colleges that prepare individuals for certifications, as well as apprenticeship opportunities. There was an emphasis on adapting training to meet the specific needs of rural areas while addressing challenges related to employee recruitment and retention in wastewater management.

# Item I: Total Dissolved Gas Modification Order for the Mainstem Columbia River (Informational)

(Governor's Office)

DEQ, ODFW and the Governor's Office provided an overview of total dissolved gas management on the Columbia River and the benefits and relative risks that voluntary spill for fish passage and the associated elevated TDG levels have on salmonids and other resident aquatic species. Oregon's current TDG Modification Order expired on Aug. 31, 2024. The U.S. Army Corps of Engineers requested DEQ renew its TDG modification to allow for the anticipated operations to proceed in the upcoming 2025 fish passage spill season. This informational item provided background in advance of an action item planned for November 2024. The presentation included additional related information regarding agreements Oregon, Washington, the Nez Perce Tribe, the Confederated Tribes and Bands of the Yakama Nation, the Confederated Tribes of the Umatilla Indian Reservation, and the Confederated Tribes of the Warm Springs Indian Reservation of Oregon recently entered into with the United States government.

Commissioners asked clarifying questions about the effect of increasing water temperatures and the interplay with elevation. Staff noted Oregon does provide a TDG permit for lower Columbia River dams and explained some of the unique and complex issues involved. Staff discussed how temperature in all water flow will be considered as we evaluate what might be best for salmon. A commissioner also asked clarifying questions as to potential seasonal variation in the risk for gas bubble trauma. Staff noted that spill in the fall is significantly less than it is in spring and summer and provided more explanation focused on the last modification order passed in 2020. Staff confirmed that DEQ has set certain criteria for the amount of TDG which is deemed an appropriate balance for risk of impairment. During the discussion, staff confirmed the purpose of the rulemaking.

### **Lunch Break**

At approximately 11:50 a.m., the commission took a break for lunch. Chair Donegan reconvened the meeting at approximately 1 p.m.

The commission held a comment opportunity for any environmental and public health issues relevant to DEQ and EQC. Sign-ups to comment occurred shortly before the start of this agenda item, and people were asked to limit comments to three minutes or less. The commission could not accept comment on the following proposed rules:

## Item K: Aquatic Life Toxics Criteria Rulemaking (Action)

Presenters: Connie Dou, James McConaghie

DEQ staff presented proposed rules to update Oregon's water quality criteria for toxic chemicals to protect aquatic life. DEQ's last comprehensive update to these criteria was in 2004. Since then, EPA has published several new or updated criteria recommendations. DEQ proposed to adopt new aquatic life criteria for six toxic chemicals into OAR-340-041-8033 Table 30: acrolein, aluminum, cadmium, carbaryl, diazinon and tributyltin. In addition, DEQ proposed to remove Table 31: "Aquatic Life Water Quality Guidance Values for Toxic Pollutants" from OAR-340-041-8033 for clarity because the values are outdated and are not regulatory criteria.

Commissioners asked clarifying questions about the application of aquatic herbicides and pesticides which led to a discussion around DEQ's pesticide stewardship program in coordination with the Oregon Department of Agriculture, as well as other agencies who play a role.

**Action**: Adopt the proposed rules, as shown in Attachment A, to amend Chapter 340, Division 41, Rule 8033, Table 30 and Table 31 of the Oregon Administrative Rules.

## Item L: Medium Heavy-Duty ZEV Rebate 2024 (Action)

DEQ staff presented proposed rules to establish the Medium and Heavy-Duty Vehicle Rebate Program and make updates to the low- and moderate-income rebates for the Oregon Clean Vehicle Rebate Program. The proposed rules are based on direction from the 2023 and 2024 legislative sessions. The proposed MHD rebate program sets rebate levels, outlines application process and requirements for MHD purchasers and dealers, determines DEQ application review process, and creates clear conditions for

award of rebates and purchaser requirements. The proposed updates to OCVRP include establishing a stand-alone Charge Ahead fund for low- and moderate-income households.

Commissioners asked clarifying questions about how California set its rebate amounts, how the rule would advance racial equity, why Oregon and California need consistent standards and what the EV availability is for each of the vehicle classes.
