#### **Public Hearings**

Review of Planning Commission decision on File APP-1-23 denying the appeal of a Notice of Abatement issued April 14, 2023 to St. Timothy's Episcopal Church, at 401 Fir Street, Assessor's Map & Tax Lot No. 4113-05BC-07300.

In this matter, Councilor Andy Martin watched a portion of the last Planning Commission meeting. Mayor Hedenskog had been involved with St. Timothy's Church as a volunteer and manager of the kitchen from approximately 2009 to 2018. Both stated they could make an unbiased decision on this matter.

Councilor Martin encouraged everyone to attend the "Salmon Rodeo" scheduled on 10/24/23 for the fish acclamation program.

Councilor Schreiber addressed Mr. Carlson's comment, stating that the abatement is not about the services, it's about where the services are being provided, and that's why it's seen by the Planning Commission; because it's a land use issue in a residential neighborhood. He recognized Anthony Baron, the Public Works and Parks Departments, Janell Howard, and the community for their hard work and the successful reconstruction of Kidtown.



Subject: Benevolent Meal Services Code Amendment

#### Recommended Motion:

- Motion to adopt Ordinance #23-O-809 amending the Brookings Municipal Code, Title 17 Land Development Code, amending Chapter 17.124.050 Benevolent Meal Services as described in Exhibit A.
- 2. Motion to waiver fees for entities that apply for CUP under BMC 17.124.050 Benevolent Meal Services for 90 days from adoption of Ordinance 23-O-809.

## Financial Impact:

None

#### Background/Discussion:

October 25, 2021 the City Council approved a revision to the BMC providing that organizations and individuals may provide benevolent meal services to the public up to two days per week between 9:00 am and 5:00 pm, additionally, no benevolent meal service shall last more than three hours per day.

On November 7, 2023 the Planning Commission voted to approve amending the BMC to revise the number of days per week that benevolent meal services are allowed from two days to three days per week and changing the hours benevolent meal services shall last from no more than three hours per day to no more than two hours per day.

#### Reasons for considered change:

- 1. One unpermitted benevolent meal provider has expressed that the existing ordinance doesn't allow them enough days to provide meals on their existing schedule, which is three days per week.
- 2. This change will allow benevolent meal providers to provide meals every day of the week collectively, as was the initial desire of the benevolent meal providers; with <u>all</u> current benevolent meal providers being permitted (if unpermitted provider applies for permit).
- 3. The change can provide even more flexibility for emergency situations, e.g. if one provider has a situation forcing closure, then other permitted providers can pick up an additional day or two without City needing to adopt an emergency resolution.

4. This change retains the existing requirements for permits, including hour restrictions between 9am to 5pm, to minimize impact on residential neighborhoods.

Staff recommends adoption of Ordinance #23-O-809 amending the Brookings Municipal Code, Title 17 Land Development Code, amending Chapter 17.124.050 Benevolent Meal Service as described in Exhibit A.

#### Chapter 17

#### LAND DEVELOPMENT CODE

#### **Chapter 17.124**

#### SPECIFIC STANDARDS APPLYING TO CONDITIONAL USES

#### 17.124.050 Benevolent meal service

- A. Organizations or individuals providing benevolent meal services may serve meals to the public up to two three days per week between the hours of 9am and 5pm. No benevolent meal service shall last more than three two hours per day.
- B. Benevolent meal services shall comply with all applicable state and county public health requirements and shall maintain any permits, licenses, or certifications required to provide such services at all times.
- C. Benevolent meal services must utilize off-street parking facilities that comply with all applicable requirements of the Brookings Municipal Code. Off-street parking facilities shall include screening measures to reduce noise and other impacts to abutting properties.
- D. Any structures used to provide benevolent meal services shall comply with all applicable city, county, and state requirements related to building, fire, and public works standards,
- E. An organization providing benevolent meal services must meet the requirements of a charitable organization under Section 501(c)(3) of the Internal Revenue Code. [Ord. 21-O-795 § 2 (Exh. A).]

I want to be clear that neither I nor my church, St. Timothy's Episcopal Church, has requested a change to the benevolent meal service ordinance. We continue to maintain that the ordinance is unlawful regardless of whether it limits meal service to two days a week or three.

#### Recommended Motion:

Motion to authorize staff to participate in the regional Assistance to Firefighters Grant process for the purchase of up to 16 Self-Contained Breathing Apparatuses.

#### **Financial Impact:**

A match may be required.

#### Background/Discussion:

Since 2001, FEMA/Department of Homeland Security's Assistance to Firefighters Grant (AFG) has helped firefighters and other first responders obtain critically needed resources necessary for protecting the public and emergency personnel from fire and related hazards. In 2003, the Brookings Fire Department was awarded an AFG grant to purchase 20 Self Contained Breathing Apparatuses (SCBAs) and 40 air bottles.

The SCBAs, while still in NFPA compliance, are at the end of their lives. The ability to remain in service is difficult, as the manufacturer is not making parts for this model anymore and repair costs are increasing when we can get parts. Last budget cycle, the Fire Department was authorized to purchase four (4) new SCBAs, for \$40,000, as we had some that were nonrepairable. These four have been ordered, and will be delivered later this year.

The Brookings Fire Department and several other fire departments in the county are collaborating to apply for an AFG grant to purchase the same type, make and manufacturer of SCBAs to better meet the interoperability within the county. The Brookings Fire Department is looking to purchase up to 16 more SCBAs with the grant funds.

Staff is requesting Council support and approval to participate with other fire departments in our county in a regional Assistance for Firefighters Grant (AFG), for the purchase of up to 16 SCBAs,

including agreeing to comply with any and/or applicable State and/or Federal Laws, rules and regulations with regard to procurements, reporting and accountability.

At this time, we do not know the match percentage; that should be disclosed in the 2023 Grant Guide, expected to come out in December. However, last years' match was 5%.

The Fiscal Year (FY) 2022 Assistance to Firefighters Grant (AFG) Program is one of three grant programs that constitute the Department of Homeland Security (DHS), Federal Emergency Management Agency's (FEMA's) focus on enhancing the safety of the public and firefighters with respect to fire and fire-related hazards. The AFG Program provides financial assistance directly to eligible fire departments, nonaffiliated emergency medical service (EMS) organizations, and State Fire Training Academies (SFTAs) for critical training and equipment. The AFG Program has awarded approximately \$8.1 billion in grant funding to provide critically needed resources that equip and train emergency personnel to recognized standards, enhance operational efficiencies, foster interoperability, and support community resilience. Since FY 2018, the AFG Program has awarded more than 600 fire apparatuses, 102,000 personal protective equipment items, and 124,000 other fire equipment to over 3,800 unique recipients. During the same period, the AFG Program awarded 588 recipients approximately \$90 million to modify department facilities or implement wellness and fitness

The AFG Program represents part of a comprehensive set of measures authorized by Congress and implemented by DHS. Among the five basic homeland security missions noted in the DHS Strategic Plan for Fiscal Years 2020-2024, the AFG Program supports the goal to Strengthen Preparedness and Resilience. In awarding grants, the FEMA Administrator is required to consider:

- The findings and recommendations of the Technical Evaluation Panel (TEP);
- The degree to which an award will reduce deaths, injuries and property damage by reducing the risks associated with fire related and other hazards;
- The extent of an applicant's need for an AFG Program grant and the need to protect the United States as a whole; and
- The number of calls requesting or requiring a firefighting or emergency medical response received by an applicant.

The <u>2022-2026 FEMA Strategic Plan</u> creates a shared vision for the field of emergency management and sets an ambitious, yet achievable, path forward to unify and further professionalize emergency management across the country. The AFG Program directly supports Goal 3 to Promote and Sustain a Ready FEMA and Prepared Nation. We invite all our stakeholders and partners to join us in building a more prepared and resilient nation.

In 2021, the National Fire Protection Association (NFPA) published a needs assessment survey, highlighting challenges that departments across the nation faced with a lack of equipment, training, and health programs. The results revealed nearly two-thirds of departments have firefighters wearing personal protective clothing that is 10 years old or older; 21% of department personnel who perform emergency medical services have no certifications; 72% of fire departments do not have programs to maintain basic firefighter fitness and health; and nearly three-quarters (73%) of all fire departments in the U.S. do not have a behavioral health program. The needs assessment underscores the widespread lack of equipment, training, and health programs required for the life and safety of emergency personnel. The AFG Program seeks to meet those needs and bring such entities into compliance with industry standards.

#### Recommended Motion:

Motion to authorize the City Manager to sign an MOU with Curry County to provide building inspection services.

#### Background/Discussion:

The City and County have had an agreement for building inspector services for many years. Historically, the City provided the County some of those services. In June 2021, the City entered into an MOU with Curry County for building inspection services, as the City building inspector did not have all of his certifications. At this time, the City's building inspector has all except commercial certification, so this agreement is still needed. Curry County has agreed to continue to provide those services under the attached draft MOU; increasing the rate from \$55/hour to \$65/hour.

# MEMORANDOM OF UNDERSTANDING By and between Curry County and City of Brookings

This Memorandum of Understanding is made by and between Curry County ("County"), and the City of Brookings ("City"). The parties agree as follows:

- 1. **TERM:** This Contract shall commence on October 1, 2023, and shall continue until this agreement is cancelled by either party as described in Section 6.
- 2. **SERVICES:** The County shall provide professional residential and commercial building inspection and plan review services to the City. Services shall include residential structural and mechanical, residential plumbing, manufactured dwellings, commercial structural, commercial mechanical, commercial plumbing, and plan review. Inspection services require a 48 hour notice from the City. The service area is within the city limits of the City of Brookings.
  - 2.1. The County Building Official shall set priority for inspections but shall have requested inspections completed within 48 business hours of receipt baring time out of office.
  - 2.2. The City will provide the County Building Official with a copy of all application forms, report forms, and other related materials to be used in the conduct of City services.
  - 2.3. Except as otherwise specified, all original files and records related to the City's building permit applications shall be retained at the City offices for the term of the agreement.

Acceptance of plan review and/or inspection service requests will be based on availability and determination of any conflicts of interest. Plan review shall be done in order once received.

- 3. **PAYMENT:** The billing rate for services provided by the County Building Official is \$65.00/ hour for services described in section 2. Plan Review fees shall consist of the entirety of the plan review fees collected by the City but at minimum but shall not be less than \$65.00/ hour. Payments shall be made monthly upon completion of the work and receipt of invoice.
- 4. **INDEMNIFICATION:** Each party shall defend, indemnify and hold harmless the other party, it's officers, agents and employees, from any and all claims, liabilities, demands, damages, actions or proceedings arising from or related to the negligence, wrongful acts, or omissions in connection with the performance of any services under this contract.
- 5. LIABILITY FOR DAMAGE OR INJURY: The City understands and agrees that the County assumes no responsibility or liability for any damage, injury, or loss resulting from or arising under this agreement at any time. The City hereby waives, releases and discharges the County, its officer agents, and employees from any and all claims, losses, suites, damages, liabilities, and proceedings of any kind or nature which may arise at any time for any damages or injuries to persons or property arising or resulting from activities under this contract. The City of Brookings covenants not to sue or initiate any type of proceeding or claim against Curry County, its officers, agents and employees for any damages, injuries, claims, or losses of any kind resulting from the activities under this contract.
- 6. **TERMINATION:** Either party may terminate this agreement at any time upon written notice to the other party.

- 7. THIRD PARTY BENEFICIARY: Curry County and the City of Brookings are the only parties to this contract and are the only parties entitles to enforce its terms. Nothing in this contract gives, is intended to give, or shall be construed to give or provide any benefit or right, whether directly, indirectly or otherwise, to third persons unless such third persons are individually identified by name herein and expressly described as intended beneficiaries of the terms of this contract.
- 8. **NOTICES:** Any notice required by this contract must be given by email or in writing by personal delivery or by certified mail return receipt requested to the following address. Any notice so mailed shall be deemed to be given three (3) days after mailing. Any notice by personal delivery shall be deemed to be given when actually delivered.

Subject: Award contract for bond counsel services for the USDA Bonds

#### **Recommended Motion:**

Authorize City Manager to sign agreement with Hawkins Delafield & Wood in the amount of \$25,000 for bond counsel services for the USDA Bonds.

#### **Financial Impact:**

\$25,000 from the Wastewater System Replacement Fund budget.

#### Background/Discussion:

In April 2022, USDA-RD approved loan funds of \$24,996,000 and grant funds of \$2,569,000 for the Wastewater Treatment and Sewer Line Improvement Project.

In March 2023, Council adopted a resolution and USDA RUS Bulletin 1780-27 Loan Resolution form for each loan/grant.

Staff requested proposals from three legal firms that work on USDA financing projects. We received three quotes. All three are reputable firms with offices in Oregon. Hawkins Delafield & Wood does the majority of municipal utility revenue bond transactions in Oregon. We believe their experience, expertise, and good relationships with USDA staff, will allow the smoothest process for the City. Staff recommends awarding contract for bond counsel services to Hawkins Delafield Wood.
