V. DISCUSS OPERATION OF ANIMAL SHELTER

• Police Chief Casey's perspective

Chief Casey said that the plans set out already by the Newberg Animal Shelter Friends (NASF) are good. He said it would be difficult to maintain funds on a yearly basis to keep the shelter running just on fundraising, so it makes more financial sense to have the shelter overseen by the City, but make sure everyone is involved to keep it running. There is no reason we can't all work together to make this work.

Councilor Rierson said that seemed appropriate due to resources for the City to run it, but we have a high need for volunteers. It is integral to have the help of the NASF.

Terry asked if Brian saw it being set up similar to the Library Board, which goes over the policies.

Chief Casey answered he could envision that.

Darlyn Adams mentioned that NASF would not continue to fundraise as much as they do now. She asked if NASF builds the shelter and then turns it over to the City, would the City lease it back to the NASF for \$1 a year.

Chief Casey said he would not know how that would work, but sees the shelter under the umbrella of the City.

Mayor Andrews asked how would the responsibilities of personnel be worked out.

Chief Casey replied there are things only the animal control officer can do and we will see what NASF can do and then go from there.

Councilor Boyes asked how much is the current animal control budget.

Chief Casey said he does not know the exact answer because he does not have the budget in front of him, but guesses it is around \$100,000.

Chair Palmer asked how many service calls came in for animal control.

Mary said last week there was over a hundred, but I do not know an average. I can get more concrete numbers for you.

UPDATE ON CITY/COUNTY PARTNERSHIP TASK FORCE VI.

Councilor Mike Boyes give update

Councilor Boyes said he spoke with Commissioner George and she mentioned that the County is self supporting with fees. She mentioned that Ken Summers is one the one in charge of overseeing the county shelter. He asked if the City collects any sort of fees.

Chief Casey answered the City collects around \$40,000 for licensing fees within the City limits.

Councilor Boyes said they might pursue giving the shelter services to Newberg.

Terry said he thought the County wanted to contract with many cities and get rid of theirs.

Discussion ensued on how the revenue from the county shelter might be shared with Newberg and the State requirement for County dog control.

Mayor Andrews asked if Newberg collects Dundee's licensing fees.

Chief Casey answered he is currently in discussion with the Dundee Manager about that.

Discussion ensued on increasing the vets incentive for collecting the licensing fees from \$1 to \$2 and looking into doing a campaign to have dogs licensed.

Terry suggested having local vets at the next meeting to get their ideas on this matter.

VII. UPDATE ON ANIMAL SHELTER TOURS

Terry handed out a list of questions for the task force to ask. Discussion ensued on the current list of questions and additions.

Chair Palmer mentioned he wanted the tours to be completed and a report of the findings at the next meeting. It was decided to visit Clatsop County, Wasco County and Hood River.

VIII. OTHER BUSINESS

Terry handed out a memo from the City's Economic Development Coordinator David Beam. Discussion ensued on what information David was requesting and who was going to provide David with the information.

Darlyn Adams handed out a letter she wrote to James Bennett.

Chair Palmer said the Subcommittee would wait to hear Jim's response to the letter.
