Michael Rossman, of Newberg brought before the Commission his concern with the traffic issue of drivers running red lights on 99W & N Brutscher St. Would like to ask the Commission if there was a way to implement some sort of safety measure such as the Red-light cameras in Sherwood on 99W & Sunset Blvd. Mr. Rossman feels that it would be a good way to persuade drivers to abide the traffic laws before someone gets hurt.


Commissioner Rogers addressed Mr. Rossman concerns by informing him that the City has had Red-light cameras in the past at the intersection of 99W & Springbrook. These were removed when the Bypass was being constructed and that intersection was being worked on. Member Rogers is aware that implementing Red-light cameras again is currently under discussion between the City Manager and the Chief of Police. Mr. Rossman said he has had a discussion with the City Manager and was informed by him that this was one of his priorities.

Chair Musall is also interested in the Red-light cameras and would like to see additional information about them. Specifically, data study's that refer to the traffic safety benefits and disadvantages of implementing them. He has witnessed instances that looked like the Red-light cameras could have a potential to create traffic issues by drivers being afraid of the light and breaking too suddenly.

Commissioner Rogers informed Mr. Rossman that the Traffic Safety Commission is looking for additional members and thought he would be a good asset to the Commission. Mr. Rossman said he had already applied to be a member of that Commission.

IV. REPORT OF FINAL DISPOSITION OF AGENDA ITEMS FROM PREVIOUS MEETING

CDD Rux informed the Commission that the County Board of Commissioners approved the NUAMC Bylaws and the amendments to the Intergovernmental Agreement on September 22, 2022.
