On December 11, 2024, DEQ received a request from Maul Foster & Alongi on behalf of Eagle Foundry Co. (Eagle Foundry) for a 60-day extension of the deadline for submittal of the Cleaner Air Oregon (CAO) Modeling Protocol (Protocol) and a 29-day extension of the deadline for submittal of the CAO Risk Assessment Work Plan (Work Plan). Per DEQ's letter dated December 4, 2024, the Modeling Protocol is currently due on January 3, 2025, and the Risk Assessment Work Plan is due on February 3, 2025. Eagle Foundry proposes to submit a combined Protocol, Work Plan, and Risk Assessment by no later than March 4, 2025, to expedite the overall CAO Risk Assessment process. Eagle Foundry is requesting additional time to allow for the preparation of all three reports simultaneously.

DEQ may grant an extension based on the criteria set in OAR 340-245-0030(3), which require sources to demonstrate progress towards completing the submittal and show that a delay is necessary for good cause. DEQ understands that Eagle Foundry has devoted significant time and resources to the CAO process to date and has worked closely with DEQ on source testing and the Emissions Inventory. Further, concurrent submittal of the Protocol, Work Plan, and Risk Assessment will be more efficient for both DEQ and Eagle Foundry and will likely lead to a significantly earlier approval of the Risk Assessment and issuance of Eagle Foundry's Toxics Air Contaminant Permit Addendum.

For these reasons, DEQ approves Eagle Foundry's request and grants an extension from the original submittal deadlines for the Protocol and Work Plan. Additionally, as part of this extension request approval, Eagle Foundry must submit the final Risk Assessment under the same deadline as the Protocol and Work Plan. Therefore, Eagle Foundry's Protocol, Work Plan, and final Risk Assessment must be submitted by **no later than March 4, 2025**.
