COUNTY DEED TO MUNICIPAL CORPORATION

THIS DEED is made April 1996 by Yamhill County, a political subdivision of the State of Oregon ("Grantor") to the City of Newberg, a municipal corporation of the State of Oregon ("Grantee").

- A. The real property described below was acquired by Grantor in 1924 in fee simple for county road purposes. (Book 94, page 494 of the Deed & Mortgage Records of Yamhill County, Oregon.) The property is no longer necessary for county road purposes. Grantee has requested Grantor convey the property for future use as a fire station. The property is identified in county records as Tax Lot 3216BC-01300.
- Under ORS 271.330(1) a political subdivision is granted express power to relinquish title to any property not needed for public use to another governmental body, "providing such property shall be used and continue to be used for a public purpose by the governmental body."
- C. On January 10, 1996, the Yamhill County Board of Commissioners held a public hearing to consider the conveyance of the subject property to Grantee in accordance with ORS 271.330(1). By Board Order 96-043, the Board authorized the conveyance. This deed is made to complete the transfer as authorized.

NOW, THEREFORE, Yamhill County, Grantor, by virtue of the statutes of the State of Oregon, does hereby release and quitclaim to Grantee all right, title and interest to the real property described in the legal description attached as Exhibit "A", incorporated into this Deed by reference, in the form of a fee simple, with the following possibility of reverter: For so long as the property is used for a public purpose, title to the real property herein described remains vested with Grantee. If the property is not so used, title automatically reverts to Grantee, and no action on the part of Grantee is required.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$0.
