Why this is important

Commissioners will have the opportunity to request, or provide, updates on items from recent commission meetings and discuss future meetings with DEQ staff. During this item, staff and the commission will discuss the annual selfevaluation survey for commissioners, a required assessment and Key

Performance Measure for the agency.

Background In 2007, the Department of Administrative Services implemented a

> requirement for annual self-assessment of all state agency boards and commissions. The data from the Environmental Quality Commission's survey is incorporated as a DEQ Key Performance Measure, updated yearly and included as part of the agency's budget submittals. The first year of EQC data

was recorded in 2008, assessing meeting year 2007.

Due to mid-year changes in membership, the commission was not able to complete an assessment for the 2016 meeting year. The commission will be asked to complete a self-evaluation survey in April or May for the 2017 meeting year, with final results brought for review and approval at the July

2018 EQC meeting. This informational item is an opportunity for

commissioners to review past data and provide feedback on possible changes

to the 2017 survey.

EOC involvement There is no commissioner action required during this item. Commissioners and staff will discuss any follow-up information from recent EQC meetings, including any updates from staff on DEQ actions in response to commissioner requests or information provided by meeting attendees. DEQ staff will also present information about upcoming EQC meetings and solicit input from the commissioners for planning meeting agendas.

EQC self-evaluation survey results and analysis for 2015 meeting year

Overall score: 95 percent

Target: 100 percent

Four commissioners and one liaison to the commission, representing another state agency's board or commission, completed a self-evaluation survey in summer 2016. The results, seen below, were averaged for an overall score. Answers marked "Do not know" did not have a percentage result, and were not used to create the individual or averaged total scores. In 2015, and at the commission's request, DEQ updated the survey to include two new questions regarding the implementation of a liaison program among several state agencies and boards. Those questions are recorded at the end of this report but their responses are not included in the overall score for Key Performance Measure data.

To note, the survey omitted one question, formerly number four, as DEQ did not present an Annual Progress Report to the commission during 2015. This report will be presented to the commission in 2016, and the next survey will reinstate this question as it will be applicable.

Areas of strength

Generally, the commission displays strength and confidence across all topics and questions in the survey. Survey results indicate that the commission is generally satisfied with the information provided by DEQ, and the overall score trend is for generally stable results. The jump in percentage between 2010 and 2011 may be attributable to better information from DEQ to the commission and a revision to the survey instrument that made the questions more relevant and specific to EQC meetings and events.

Areas for improvement

The commissioners scored question four the lowest, at 80 percent and multiple "other" responses which do not have a percentage, with comments indicating a need for potential changes or improvement. This question addresses communication from DEQ about key issues, and the comments indicate confidence in this score improving for the 2016 meeting year as staffing changes in the 2015 meeting year may have impeded consistent and reliable communications.

2008: 100 percent – First year of measurement, used only a yes/no ranking scale

2009: 90 percent – Started using the scale of 0, 40, 80 or 100 percent ranking scale

2010: 82.3 percent

2011: 96.7 percent – Revised questions for additional relevancy
