## 2016 Agenda & Priorities

## A Seamless System of Education

- Establish the Education Innovation Officer charged to improve Oregon's high school graduation rate.
- Create the Governor's Council on Educator Advancement: Executive Order establishes the Governor's Council on Educator Advancement, charged with coordinating comprehensive support to deliver excellence in teaching through leadership development, mentorship and best practices.

## A Thriving Statewide Economy

- Support small business:
  - Legislation to expand the Office of Small Business Advocate to help small businesses navigate state and local policies and procedures.
  - Governor's Small Business Advisors: Executive Order creates a diverse advisory group to develop recommendations to support Oregon small businesses, such as increasing access to capital and streamlining state agency processes.
- Legislation to increase the minimum wage.
- Legislation to continue the expansion of affordable housing issues statewide.

#### **Excellence in State Government**

- Accountability and Transparency:
  - Legislation creates a technical ombudsman in the Department of Administrative Services to assist state agencies with large electronic public records requests.
  - Executive Order requires all agencies to comply with current law requiring state agencies to have a public records policy in place; DAS to implement the 2015 audit recommendations, including uniform statewide standards.
  - Legislation tightens deadlines by which lobbyists must disclose/register clients with the Oregon Government Ethics Commission (OGEC), and requires OGEC to make that information available online within two days.

## Healthy, Safe Oregonians

- Establish the Governor's Campus Safety Working Group.
- Umpqua Community College funding proposal funds to enhance safety on the UCC campus.
- Harney County funding proposal funds to offset expenses incurred during the occupation of the Malheur Wildlife Refuge.

## Responsible Environmental Stewardship

- Appointment of State Resilience Officer.
- Drought package funding proposal funds to help local communities plan for and address persistent drought.
- Wildfire funding proposal funding to cover costs incurred during the 2015 wildfire season.

## Issues to inform decisions for DEQ Policy Option Packages and Legislative Concepts

#### Program needs related to core work

- Agency Infrastructure / technology modernizing at DEQ Preparing for and selecting an environmental data management suite, an integrated set of software programs to replace existing, outdated technology systems.
  - <u>Project management office</u> DEQ has used project management resources for some of its larger projects to great success. This approach has proven to be effective at improving our timeliness on project delivery, minimizing impacts on daily operations and ensuring efficiencies and/or redirection are sustainable. We seek to build on this success and create a Project Management Office. An additional FTE is being considered to staff this office for large non-information technology projects.
  - Business analysis support ongoing outcome-based management process improvements are backlogged due to high demand. Adding staff to support continuous process improvements at DEQ needs to be considered to ensure process improvement success across the agency.
  - <u>Leg concept</u> may be needed to address electronic reporting and invoicing inconsistencies and barriers in statutory language.
- <u>Fee requests and bonding</u> A majority of DEQ operations are funded by fees and DEQ is considering the
  need for fee increases in 2017. The agency is identifying all potential fee increase needs and will
  determine which ones are positioned to go forward in 2017, based on a number of considerations
  including: alignment with program direction and agency priorities, a fee surcharge concept for technology
  projects, annual cost adjusters as part of a leg concept, bonding requests for cleanup and the clean water
  state revolving fund; and stakeholder support.
- <u>Materials management</u> DEQ developed a six-year strategy to implement the 2050 Vision for Materials Management. This program had two successful bills in 2015. The work accomplished in 2015-16 sets the foundation for a 2017 request.
- MS4 stormwater Significantly understaffed, DEQ is examining options to improve delivery of the MS4 stormwater program
- Agency complaints / nuisance response as public expectations for action grow, the agency is looking for
  ways to better address the approximately 2500 complaints received each year. This includes looking at
  general complaints as well as addressing formal nuisance investigations that focus on a single or multiple
  groups of sources. It may also address smoke management related to wildfires and prescribed burning.
- Spills response and disaster recovery There is growing awareness of the impacts of a very large
  Cascadia earthquake. DEQ is effective at responding to smaller disaster events but needs to plan for its
  response in a major earthquake. The agency is considering what is needed to ensure DEQ can fulfill its
  role in a major disaster.

## **Emerging issues for DEQ**

- Harmful Algal Blooms This unfunded work is becoming more costly as HABs are becoming more frequent. We may seek money to support this work. Coordinated effort with OHA and Governor's Office.
- <u>Clean Power Plan (placeholder for POP and/or LC) implementation of 111(d) in the form of a statewide plan submitted for EPA approval; work is being done in conjunction with DOE and PUC. There is a tie-in to biomass that may require more resources.</u>

#### Externally driven issues

- Woodstoves and PM attainment issues This is ongoing policy work for DEQ and is tied to the 2015-17 interim study bill, including the establishment of a legislatively mandated task force and submittal of legislative recommendations. This effort includes a number of sister agencies such as DOE, PUC, OHA, Housing and ODA. This may tie-in to biomass.
- <u>Clean diesel</u> There is an understanding that a legislatively-created workgroup will be created in the near future with a high likelihood for a legislative concept in 2017 sponsored by legislators or stakeholders. There is a linkage to DEQ's air toxics benchmark review which is underway.
- <u>Climate Change / emissions (carbon tax, life cycle, ZEVs)</u> Legislators are showing interest in
  introducing one or more bills in 2016 and depending on the outcome, perhaps more bills in 2017. It is
  highly likely DEQ will have significant responsibilities related to this potential legislation. There is a likely
  tie-in to biomass.
- <u>Placer Mining (suction dredge)</u> Senator Alan Bates, Ashland, is planning to sponsor legislation in 2016 that places DEQ in charge of issuing all federal / state permits for in-water motorized placer mining. There is a coordinated effort with DSL, DOGAMI and the Governor's Office.
- Onsite loan program there were extensive 2015 legislative discussions over SB 246, which would have created this program. DEQ is working with Senator Arnie Roblan, Coos Bay, and stakeholders in anticipation of a similar bill in 2016 or 2017.
- <u>Clean Water Partnership</u> this coordinated effort is being lead by the Governor's Natural Resource Office and includes OWEB, WRD, ODA, ODF, ODFW and DEQ. The work is continuing during this biennium. DEQ did not receive any POPs for this work in 2015. It is unclear if there will be a request for 2017
