Meeting Purpose

This Rules Advisory Committee:

- Serves to represent the interests of persons and communities likely to be affected by the rule.
- Reviews the draft fee increase proposal.
- Reviews and evaluates the accompanying fiscal and economic impact statement.






Underground Injection Control

Protects freshwater aquifers from contamination due to UIC use: assisting municipalities, businesses and residences statewide.

- Last fee increase was 2024.
- In 2019, administrative fees were increased 7%. Prior to 2019, rule authorization fee did not increase for 12 years.
- Sustained by 2.4 Full Time Employees

Wastewater Operator Certification Program

- In Oregon, any wastewater plant that processes domestic sewage must have at least one DEQ certified operator on duty.
- This statute affects ~400 public and private wastewater systems.
- Program is 100% fee-funded.
- ~1400 certified operators.
- Last fee increase: 3% in 2024; prior to that: 60% in 2013.
- Sustained by 2 Full Time Employees








401 Water Quality Certification

- Issue state water quality certifications for projects that require a federal license or permit that may result in a discharge to waters of the US.
- Reviews applications from municipalities, federal agencies, state agencies, businesses & residences.
- In 2013 DEQ instituted a 401water quality certification fee structure with five-tiered fee options.
- Sustained by 4 Full Time Employees

Water Quality Permitting

The WQ Permitting Program maintains, enhances and protects Oregon's waters by regulating pollutant discharge through the permitting process.

- The program develops and implements:
 - 311 NPDES Individual permits
 - 197 WPCF Individual permits
 - o 963 General permit registrants
- This program has been a part of the annual 3% WQ fee increase for the last several years
- Sustained by 87 Full Time Employees

Onsite Wastewater Management

- Oversight of statewide septic system program
- Licenses sewage disposal services
- Directly manages septic service permits
- Last fee increase was 17% percent in 2024
 - 14% of the increase for new positions
 - 3% of the increase towards offsetting increased operating costs and expenditures
- Sustained by 14 Full Time Employees





Fiscal Impact Statement

Racial Equity

Adoption of the proposed rule would affect water quality fees statewide - across various sectors, public and private. Since the fee increase will apply equally across all categories and tiers, and there are no expected changes to practical implementation of the water quality program activities as a result of this rule adoption, there is no expected impact on racial equity in the state. Increasing the fees, as proposed, will help maintain program services critical to protecting public health and the environment (such as permit compliance assurance, inspections and enforcement) which may be particularly important in BIPOC or historically underserved communities
