Summary of Public Comments Federal Street Plaza

The following summaries input received during the 2.12.24 Public Open House, online comments, and emails provided by the public.

Key Themes:

Activities and Interactive Features:

- Water features (e.g., splash pads): strong emphasis, preference for the style shown in scheme B.
- Ambient running water
- Misters for hot weather
- Ice-skating in winter
- Chess/board game tables
- o Interactive installations: shuffleboard, bocce ball, ping pong, RC car races, labyrinths...
- o Kinetic sculpture, not murals.
- Some suggested incorporating heritage murals and improving the facades of surrounding buildings.
- Use the Craig Building wall for interactive games: wall ball, climbing, etc.

Plaza Amenities and Infrastructure:

- Emphasis on shade through both canopies and trees
- Drinking fountains, including for dogs
- o Bike repair kiosk.
- Seating with back support.
- Swing benches.
- o Full circle tree seating.
- Utility hookups for food vendors
- Adirondack chairs, etc. movable furniture
- Like shade but not a fan of the arbor structures
- Dark sky compatible lighting
- River City scheme is broken into two "rooms" by shade structures; seems easier for varied group sizes to find spaces and occupy on a day-to-day basis.
- A welcoming transitional space between the plaza and surrounding areas.

Greenery and Natural Elements:

- More planting and seasonal blooming
- Shade trees with seating
- Basalt seating
- o Drought-tolerant and native plants
- Visual screening from traffic on 2nd St.
- Consider areas of lawn, grass pavers, or turf rather than concrete pavement to reduce heat island effect.

Materials and Character:

- o Scheme A was preferred by some for its clean, modern look and structural solidity.
- Scheme B was favored for its tiered seating, shade features, and flexible community spaces.
- Use of local, natural materials like basalt and pine
- o Preference for real basalt over concrete/abstractions of nature
- Less concrete and less paving overall.
- Concerns about the heat absorption of concrete.

- More vibrant, colorful materials vs. typical "industrial gray."
- o Historic brick from the Tony's Bldg. available for use
- Fishing-platform-inspired canopy structures
- o River pattern in the paving
- Organic forms like shown in the Basalt scheme.
- More "Instagrammable" spaces to attract visitors.

• Community Programming:

- Community art projects
 - 1. Native art
 - 2. Student art Collaboration with school district
 - 3. Rotating installations
- Performance art: Theater, live music
- Community events: Happy hours, picnics, trivia nights, dance nights, yoga classes, farmer's markets.
- Multi-generational programming.
- Community gardens.
- Plaza should support/encourage visitors to engage with local businesses.

Safety and Accessibility:

- ADA-accessible restrooms
- Senior-friendly seating
- o Bollards at 2nd St. and 1st St. for pedestrian safety
- Ample lighting throughout
- Mitigation of drug use and other safety concerns at fountains and planting beds. Given the camping along 1st St., undesirable use of the plaza will be a critical issue to manage.
- Discussed safety benefits of relocating the restroom in Transportation Building.

• Event and Performance Spaces:

- Power and water hookups for vendors and events.
- Mix of preferences between pop-up vendor spaces and dedicated areas for food trucks, stages, and other event infrastructure.
- Support for flexible event spaces and vendor stalls.
- Stage near Transportation Building may provide good acoustics.
- Consider locating a stage near 2nd St. facing north.
- Expand canopy shown in Basalt Scheme near Transportation Bldg. as a stage.
- Movable furniture that can be brought out for events.
- Some respondents felt that neither design fully accommodated large events or gatherings.
- Concerns were raised about the lack of an amphitheater, tiered seating, or clear sightlines for performances and public speakers.
- Suggestions included reconfiguring spaces to allow for a central performance area or adding terraced seating.
- Concerns about reductions in usable space for the Cherry Festival with the new plaza, and desire to collaborate on solutions.

Transit and Access:

- Evaluate parking impacts to downtown.
- A significant number of respondents raised concerns about the loss of parking spaces, especially in a congested area.
- Specific concerns were expressed about parking for nearby businesses and tenants.
- Some suggested a no-parking zone on 2nd Street or the need for a parking plan to address event-driven congestion.
- Accommodate sufficient truck access for businesses along the alley, including on 1st St.

- o Provide space for a future transit stop.
- Better integration with public transit, including additional bus shelters that complement the plaza design.

• Management and Maintenance:

- Concerns that fabric canopies will be less durable than fixed arbors.
- Movable furniture requires management/security.
- Irrigation critical for tree and plant survival
- Permeable surfaces are for better drainage.
- Significant concern about city's ability to manage the space day and night and to keep active.
- Reach out to community orgs and local businesses to sponsor amenities i.e. the arbors, seating, or fountain.
- o Plan for long term management and maintenance costs.
- Concerns about the fee structure for use of event spaces and potential conflicts with other local event venues if plaza events are free.

• Transportation Building Uses:

- Visitor's center including for people arriving via the Gorge trail.
- Concessions
- Check-out for recreation equipment, like ping-pong or bocce
- Storage for equipment and furnishings
- Art gallery

• Compatibility and Future Planning:

- Design compatibility with a potential future train station.
- o Preservation of historical agreements related to the veterans' museum.
- Consider ways to extend the plaza to 2nd and 3rd street blocks, like Portland's Park Blocks

1.15.25 Committee Input and Direction

- Proceed with Scheme A River City with modifications.
- Use of wood is good.
- Trees and seating together are preferred.
- Seeking a prominent element to light up (i.e., shade structures)
- Fountain style of Scheme B with rocks and seating is preferred.
- Generally, the basalt features were very well received.
- Include water bottle filling station, maybe dog dish at the water fountain.
- Debate over shade canopies tensile look interesting and maybe provide better shade, but arbors are more durable and have a sense of permanence.
 - Request to see cost options for both.
- Terraced seating in Scheme A could be made of basalt or concrete modules.
- Prefer the paving pattern in Scheme A given it is inviting and flows into the plaza.
- Some concerns about basalt in the fountain obstructing circulation or events
- Evaluate using fishing platforms as inspiration for shade structures. Seek other local, historic structures as inspiration.
- Bike hub is in preferred location providing good balance of being visible and not overpowering the plaza.
- Examine a variety of lighting concepts. Consider period lighting.
- Consider temporary umbrellas or other shade until trees grow and provide canopy.
- The Ned Kahn style art wall could provide visual interest.

Walker Macy Recommendations for Design Refinement:

- 1. Use the River City scheme as a basis of design.
- 2. Incorporate elements from the Basalt scheme like the basalt seating, organic forms, where appropriate
- 3. Consider the relationship of future fermentation hub at Tony's Lot and the plaza as part of the final conceptual design.
- 4. Incorporate 1.15.25 Committee Direction
- 5. Determine with committee how to prioritize and incorporate community input.

Recommendations for the Committee:

- 1. Reach out to community organizations like the high school art program, the college, etc. to gauge interest in collaboration for installations and programming.
- 2. Reach out to community organizations who may be interested in sponsoring parts of the project like the shade structures, benches, and the fountain.
- 3. Evaluate the City's ability to manage the various uses discussed, both programmatic and security/maintenance, and assess what is realistic to provide.
- 4. Discuss uses for the Transportation Building that support the plaza's goals as a community gathering space and gateway to The Dalles.
