**Background** DEQ's Agency Rules Coordinator is responsible for filing materials with

the Secretary of State on behalf of DEQ. That responsibility is a delegated

authority given by the commission.

Maggie Vandehey, DEQ's long-time rules coordinator, is retiring and her authorization must be rescinded and her position's replacement given the

appropriate administrative authority to file rules and take other

administrative actions on behalf of DEQ.

If approved and signed, DEQ will file the withdrawal of rulemaking, attachment A, with the Secretary of State and it becomes effective immediately. The delegation of administrative functions, attachment B, is retained by DEQ and would allow Meyer Goldstein, the new Agency Rules Coordinator, to provide administrative functions for the agency with no

lapse in authority.

DEQ recommendation and EQC motion DEQ recommends that the commission authorize the Chair O'Keeffe to sign the rulemaking delegation withdrawal, as seen in attachment A, and authorize Chair O'Keeffe to sign an updated delegation of administrative

functions, as seen in attachment B.

#### **Delegation of Administrative Functions**

The Oregon Environmental Quality Commission delegates to the Director the authority to commence rulemaking proceedings. The Commission further delegates to the Director, Commission Assistant and Agency Rules Coordinator the authority to take all ministerial actions necessary for rulemaking under ORS 183,325 to 183.410, OAR 340.020, OAR 137, division 1, and OAR 340, division 11, including, but not limited to, publication of notice of proposed rules, taking of public comment on proposed rules, holding public hearings on proposed rules, and filing of documents with the Secretary of State, Legislators and Legislative Counsel.
